There is no way to escape the pain this book will produce. This information was difficult to research, to retrieve and extremely difficult to discuss in writing. The information is overwhelming and it is not possible to read this book without enduring excruciating pain. Pain is not our objective nor is sensationalism. Our objective is to bring about a permanent change in the status of the American woman and the women of the world. To meet this objective, we provide penetrating information. All too often, information regarding the death of an American female is taken as an isolated event, thereby making her death digestible and easy for the women of this country to accept. Although the murders are important, over time, the murders become inconsequential because many women think the murders have nothing to do with one's everyday life. Therefore, the full impact of the number of women murdered in this county is not appreciated. Collectively, the murder of over 200,000 American women is important when one can sit and read the cases of 20,000 women from this group. The information in this book is not being offered to sensationalize or exploit the death of these women. The information is being provided to bring recognition to their existence and their untimely deaths. We believe the women who paid the ultimate price for freedom should be immortalized. These women should never be forgotten.

This book was written in deference to the millions of women in the world who have lost their lives merely because they were women. Think of the girls in India who are raped so males can remain in control. If you have read the news out of Nigeria, you will understand males are fighting all over the world to remain in control. More than 300 school girls were taken from their families merely because they were females trying to learn to read. No one knows if these children will ever be returned home again. Women must wake to the fight for sovereignty.

Extreme care was taken in discussing the deaths of more than 20,000 American women. It was our wish to grant the victims as much dignity as humanly possible yet alert the women of this country of the horrors of their deaths. But how much dignity does a victim have when it is known she was stabbed more than 153 times? Again, we feel that you should not read this book if you have been a victim of violence or have a male or female relative or child who has been a victim of violence. If you choose to

proceed we ask you to be brave, strength will come. There is much to learn. You will not put this book down without gaining knowledge. The Career Rapist especially will be hard reading, but as women we must stand together and face the monsters in life so we can live better lives and secure a future for our children. Although *Do This in Remembrance of Me* discusses the murder of 20,000 American women, the books are about life not death.

As you read the following information, please remain cognizant that you are reading case histories of crimes committed all over the United States. No one state has the same definition or punishment for any degree of murder, manslaughter or rape. The proof and qualification for an insanity defense is different in most states, as are the requirements for the death penalty. The definitions of mitigating and aggravating circumstances are defined differently by state, as is the right of a judge to override the jury during sentencing in death penalty cases. Also, the requirement for probation is different per state, as is the punishment for juveniles and individuals who are mentally handicapped and commit capital offenses. When you read Volume Three: *The Career Rapist* and Volume Four: *The Recidivist*, you will then appreciate this difference.

You must also remember American law is not static. Our laws have been made to yield to technology that has allowed for the release of men from prison. With respect to all the data in the four volumes of Do This in Remembrance of Me, the persons listed as murderers or rapists or in the category "Murderer Status: " were individuals who at the time were apprehended, arrested, charged, tried, convicted, or suspected or alleged by the police in the murder of the women mentioned. During the course of time, some of these individuals may have been exonerated and the information was not available or recorded in the source documents used during the development of the books Do This in Remembrance of Me. We took extreme care to list as many convictions and as many exonerations and overturned judgments that we could find in the source documents used. The two categories, "murdered by stranger" and "murdered by unknown," are not clearly defined as the categories when used by the United States Justice Department. Our "stranger" category is only used when the murderer is known but the relationship was not clear in the source document. The category "murderer unknown" was used when there was no information in the source document regarding the relationship of the murderer and victim, the murderer had not been apprehended, or the victim was unidentified at the time. In some situations, some of the cases listed under "unknown" may now have been solved.

We did not intrude upon the lives of the survivors as mentioned in the foreword. It is not our intention to sensationalize or to make murderers celebrities. You may recognize several women who were murdered by men now made famous by the newspapers. We did not use the slogan names of these men. We saw no need to further the agenda of newspapers.

When the last name of a person is in brackets, this means that we were not certain of the spelling of the last name or that we used the last name of the parent because we only knew the first name of the victim. The word "mother" across from the victim's name means in most cases that the woman left behind young children when she died. The word "see" references similar cases or women who were murdered together or murdered by the same person. Again we caution you: please do not read this book if you have been a victim of violence or have a male or female relative or child who has been a victim of violence. There is no way to escape the pain reading the following passages will cause. This information is upsetting, but we must have courage. If you choose to proceed, we ask you to be brave; strength will come. This section will be hard reading, but as women we must stand together and face the monsters in life so that we can secure a future for our children and bring peace to our nation. There is no peace when there is violence.

To the men reading our books: you must become more aware of the possibilities of danger that your daughters will experience when they date, become engaged, or marry. You cannot help the women of this nation if you do not understand their problems.

Before you begin reading Volume Three Part Three, I would like you to read about the murder of Betty Jean Lee. Betty Lee was a 36-year-old Diné College student at Shiprock. I wrote about her in the book, It Is Time To Start Walking With God. I want her story to be read again. I think her death is important to every woman living in this country. Her murder was a non-domestic violence murder. In neither It Is Time to Start Walking With God or in this book did I completely describe how she was murdered and all of her injuries. The manner of her death overwhelmed me. I want you to see the savagery of her murder. You must understand there is violence like this in the world awaiting every woman who leaves her home for work or for play. This type of violence awaits your child. This is why it is so important that you understand that you must stand up and fight back whenever the opportunity presents itself. Do not forget this woman. She is everyone's daughter, sister and mother. We must stand up and stop the abuse of women. Every death makes us weaker. Every death makes us more unimportant. Every death destroys our self-worth until finally we will be permanently enslaved by thoughts that sexual murder is a natural phenomenon for women that we must accept our plight and live with it. Read this book as if your life was in the balance because it is. If the women of this country do not stand up for themselves, we shall perish as human beings forever to be sexual objects or objects for men to vent their frustration and fantasies.

The state Legislature in 2009 repealed the death penalty in New Mexico. But that decision did not undo the death sentences of two inmates, Robert Ray Fry and Timothy Allen of Bloomfield.

The Value of Friendship

Betty Jean Lee, 36, lived in Shiprock, New Mexico. She was the mother of five children. She was going to school to be a nurse. Her family said she was a dedicated member of the family. She was a caring person, a good daughter and sister. When her family learned of her death, they were devastated. On the last day of her life, June 9, 2000, Betty Lee went out with two of her girlfriends. The women went to a bar in Farmington, New Mexico. There the women met two men. Betty Lee did not pair up with anyone, so she became the fifth wheel. After some drinking, her two girlfriends decided to leave the bar with the two men they met. They went to a motel. Betty Lee pled with them not to leave her, but they left her stranded without a ride home. They made no effort to help her contact a family member to give Betty Lee a ride home. Betty Lee went to a convenience store to try and reach her brother, a Navajo police officer. She could not reach her brother, so she accepted a ride from a man who said he would help her. He had a smile on his face. Needless to say, he murdered her that night in the desert. After the supposedly good Samaritan and his buddy bludgeoned Betty Lee to death, the men went for a joy ride in the desert to celebrate the murder. An electrical foreman found Betty Lee's body the next morning and called the police.

Her assailants were apprehended because their vehicle became trapped in the sand the night of their joy ride and had to be towed. When Ms. Lee's body was found, the police traced the tire tracks near the body to a cell phone found in the desert several miles away. The cell phone belonged to Mr. Charlie Bergen, who explained to the police that he was called out to the desert around 3 a.m. to pull two cars and a tow truck out of the sand. His wife phoned him while he was working. He became so angry he threw the phone away (an act of God). The cell phone led the police to the men whose car's was towed. Sufficient forensic evidence was collected to charge the two men with murder. The murder weapons, a knife and a sledge hammer, were left at the scene. As usual, the weakest man confessed. Men can kill, but they do not do well under interrogation. They normally fold under pressure. It is easy to kill a defenseless woman, but it is not easy to deal with a man face to face. Murder is a cowardly act performed by cowards. The murder of Ms. Lee was so horrendous and barbaric that I will not describe it. I truly do not like these two men, so I do not want their names in this book. Over time, may their names be obliterated from humanity and they will be buried without a grave marker?

The man who did the actual killing was sentenced to death. His death sentence is remarkable because New Mexico juries do not like sentencing anyone to death. When this person was sentenced to death, there were only two men on death row in New Mexico. In New Mexico, unanimity is required for a guilty verdict as well as for imposition of the death penalty. He deserved the death sentence because, unbeknownst to the jury, he had killed two men earlier in the year. The murderer was also sentenced to 46 years for tampering with evidence and kidnapping. The second man pled guilty to the killing and is now serving a life sentence. He agreed to testify against his buddy. He said that the men noticed Betty Lee because she was sobbing because her girlfriends left her stranded. Her girlfriends practically told her, "Get home the best way you can."

Betty Lee tried to save her life after being stabbed by pulling the knife out of her chest and running back toward the road. This is when her assailant attacked her with the sledgehammer. What can be said of the women who left Betty Lee at the bar to fend for herself? Would you want your daughter to go out with these women or to call them friends? Is it not mind-boggling that Ms. Lee was murdered because she was left behind? What kind of human were her two friends? New Mexico is no stranger to violence against women. There are a host of unsolved murders involving women, and these murders have been covered in the newspapers

and the local news in New Mexico. We can list over thirty unsolved homicides involving women murdered at night. New Mexico has seen too many murders of females committed by men on the prowl at night for anyone to say that Betty Jean Lee was not in any danger when she was left alone.

We say that we are blameless and white as the driven snow, yet we wonder why God has not blessed us. The answer probably lies in our past deeds. How are you a friend if you are not responsible for your friend's safety? What is the value of a friend if you do not care for her life? How many times have you seen your friend safely home? **Now five children are left motherless.**

I considered dedicating this book to several women. Women I believed should be remembered because of the inhumanity showed them by their assailant. But since this book is tied to the murders women experience when trying to prepare for work or are actually at work I decided to dedicate this book to Maria Fernandes. I identify with her. I remember working two and three jobs just to meet the needs of my family and to get ahead. I know what it is like to drive from one job to another to work sixteen hours a day for a wage that barely keeps you alive and allow you to live with some dignity.

The death of Maria Fernandes demonstrates how important jobs are to women. Maria Fernandes lived in New Jersey. She was trying to get ahead in life. Since she was unskilled and could not afford college her coworker said she worked as many as four jobs trying to make a living. Her body was found August 25, 2014 in her car parked in a convenience-store parking lot in Elizabeth, New Jersey. She was wearing a Dunkin Donut uniform. Hazmat investigators found that fumes in Maria Fernandes' car were caused by a gasoline can that had spilled in the back, according to the release. Friends told police that Fernandes kept gas in her car to avoid running out of gas when traveling between jobs. And she often slept in parking lots to get a few hours of rest between jobs. Ms. Fernandes worked at multiple Dunkin' Donuts as little as 10 hours a week at one franchise and as many as 40 hours a week at another. Please read the Huffington Post article, "Dunkin' Donuts Worker's Death Reveals The True Cost Of Our Low-Wage, Part-Time Economy." Posted: 08/29/2014 Low wages and unreliable schedules mean that low-wage employees are often forced to work more than one job to make a living. Women suffer more than men in that regard. Women make up about two-thirds of low-wage workers. Between 2009 and 2013, 35 percent of women's job gains were in low-wage sectors compared to just 18 percent of men's.

During the 2012 presidential election much was said about the people who work in this country who do not earn a living wage. Much was said about their asking for handouts that they are waiting for the government to give them something. Yet nothing is said of all the women suffering from depression trying to work; killed by boyfriends that do not want to pay child support, women working two jobs, women suffering physical maladies because of working and caring for children alone, or working jobs without adequate health insurance

Volume Three Part Three is dedicated to Maria Fernandez courage to try to change the circumstance of her life.

You Cannot Tell A Rapist by His Appearance You Can Only Identify A Rapist by His Conduct.

His Greatest Weapon is His Smile. His Primary Objective is Opportunity.

Four women were raped and murdered in Maryland. The women were Ms. Boontem. Anderson age 34, of Gambrills, a mother of two, Ms. Elaine Buchanan Shereika age 37, a mother, Miss Lisa Haenel age 14, of Glen Burnie, and Debra Cobb age 37, a mother of two. Three of their murders remained unsolved for almost 20 years while their families anxiously awaited resolution. Boontem Anderson was murdered October 8, 1986. Elaine Buchanan Shereika was raped and murdered May 23, 1988. Elaine Shereika left her home at 5:20 am to go jogging. A health activity many women across the nation had adopted. While jogging Elaine Shereika was murdered. There are three activities that women participate in that draws stalkers; one activity is waiting on tables the other activities are jogging and walking to school. These activities allow a person to see for hours watching their intended victim from afar allowing them to gather information on their habits, timings and other associations such as the husband or boyfriend. These activities also allow for the woman to be followed home. Miss Lisa Haenel was assaulted and murdered January 15, 1993 while on the way to school. Debra Cobb, an office manager of Forestville, Maryland, was raped and murdered in 1994. Her assailant who worked in the same office plaza was apprehended, convicted then sentenced December 1994. He was sentenced to life in prison without parole. When her assailant was convicted of murdering Debra Cobb, he told the judge he had a drug problem hoping this would mitigate his sentence. He was hoping for a lesser sentence so that someday he could leave prison as a free man. He was only 24 years old. He could survive a 30 year sentenced. The man's name was Alexander Wayne Watson Jr. What no one knew the day Alexander Watson was sentenced is that Mr. Watson had been killing since he was 17 years old. He killed people he knew, he killed people who lived in his neighborhood, and he killed people strangers who crossed his path. He watched Lisa Haenel walk to school each morning. In 2004 at the age of 34 Alexander Watson was arrested in prison and charged with the rape and murder of Boontem Anderson; the rape and murder of Elaine Shereika and the murder of Lisa Haenel. Apparently in 2003 Maryland's law had caught up with technology. Three DNA samples taken from three different murder scenes matched Mr. Watson's DNA that was in the state's data bank. In 2004 the arrest was made and three families were force to once again deal with the murder of their mother, their child, their sister, their cousin etc. Three families had to sit in court and look at the man who irrefutably changed their lives forever. They came face to face with a man who was evil, a man who could never be redeemed. Mr. Watson was sentenced to three life terms in prison rather than being forced to face the death penalty for the murder of Elaine Shereika. He was an adult when he murdered her he was a juvenile when he murdered Bootem Anderson and 14 year old Lisa Haenel. No one from his family was in the courtroom when he was convicted and sentenced. This case represents the circumstances of what is consider stranger murders. In these cases the assailant and the victim have a tangential relationship. They meet at one point in time example at a bus stop, or as a customer as an employee in a liquor store or convenience store or they are linked through someone else's relationship example a son visiting his mother in a senior citizen building. In one case Mr. Watson worked at a fast food restaurant with one of the victim's son. The solution of stranger and acquaintance murders is causing investigators to now look throughout the neighborhood not just for adult males but for juveniles. You cannot tell a rapist by what he looks like or his age you can only identify a rapist by his conduct. In 2010 Mr. Guy Shannon Jr., 45, was arrested for driving while intoxicated. Because of state law his DNA was taken. When his DNA matched the DNA taken from the body a murder victim, he was arrested in 2012 for the March 1989 rape and murder of Marcia Lynn Davis, 20. Miss Davis was strangled to death. He will now have to answer in court why his DNA was found in the body of Miss Lynn who was raped and murdered in an abandoned

building in Kansas City, Missouri. The point here is Mr. Shannon has been walking around this country for 23 years looking in the faces of women and not one woman knew he was a possible rapist and murderer. Not one woman; not his aunt, not his mother, not his sister, not his grandmother, not his cousin, not his coworkers, not one woman, who came in contact with this man in the past 23 years ever thought he was capable of rape and murder. If they did they kept their suspicions to themselves. Mr. Shannon Jr. was AWOL from the Marines when Marcia Davis was murdered. You cannot tell a rapist by what he looks like you can only identify a rapist by his conduct. Now we await the jury's verdict in the death of Marcia Lynn Davis, 20, March 1989. The women of this country should say enough is enough. We need to work for legislation for these men to remain locked up forever. Why must we wait until five or six women are murdered before we act? When Gerald Montgomery, 35, was arrested for the March 9. 2007 abduction, rape and murder of Laura Winterbottom, 31, his wife said her husband had gone downtown at about 9 p.m. the night of Winterbottom's death and returned about 1:30 the next morning with a red stain down one arm. Montgomery told his wife he had "jacked" someone. Other rapists have told their wives that the blood in or on the car was because they had hit a deer on the road. Leona Montgomery told police that after the killing Montgomery was nervous, not sleeping, "and spent a number of days looking out the apartment windows as if he was waiting for something or someone." He chose to plea bargain with the prosecutor for a reduced sentence. Ms. Winterbottom was a graphic designer. She was abducted from a restaurant parking lot after having dinner with her sister. The operative word to describe a rapist is the word opportunity. Can he see an opportunity to snatch and disable his victim putting him in control? This is how Dru Sjordin was murdered. Her assailant saw an opportunity. She was talking on the phone allowing him to get close to her. All a rapist needs is opportunity. He will act. He will act immediately or return after surveilling the area several times setting up the kill scene (Lisa Haenel). A rapist is always looking for an opportunity. He will smile to appear friendly and look for isolation or helplessness in his victim. Above all he will strike. Ask yourself have I set up an environment for a rapist to strike. If so correct your behavior. The reason why the rapist has been successful is that women have failed to realized more than half the assaults committed against women are not related to domestic violence. We are so preoccupied with the word domestic violence the rapist has escaped our attention. We need to consider all assaults against women. Women can now see the extent of gender violence with the 2012 conviction of Air Force Instruction Luis Walker for rape the 2013 arrest of Mr. Ariel Castro for kidnapping, the sterilization of California women and the NY prostitution case.

This book is about the above women and women such as Tara Stratton, 18. Her assailant waited for his opportunity to strike. He did not have the face of a rapist. No one expected this behavior. What shocked most people was the assailant was so ordinary in his person. He used his position to gain access to the victim. His actions were unexpected. Who goes around raping and murdering your son's ex-girlfriend? Read carefully there is much to learn. This knowledge may save your life.

"Rot in hell!" Her grandmothers, Nancy Boucher and Betsy Stratton

Tara Stratton lived in Barre, Vermont. She was a regular teenager. In a few months of her death defense attorney would try to paint her as a person who used drugs and had illicit sex. The tactic did not work. The person Tara Stratton was, was expressed by the conduct of her family. They came to court for justice and they were patient enough to wait for it. When reading about Tara Stratton's murder trial one is struck by the number of relatives Ms. Stratton had. How lucky she was to have known both her grandmothers. This writer has never seen either of her grandparents male or female. Grandmothers are special people and people are fortunate

when they have two grandmothers alive and well at the same time. The contrast between the victim's family and the assailant family demonstrates why one should be selective in who one choses to form associations. Tara Stratton died between 10:15 p.m. on Thursday, and noon on Friday, January 17, 2003. When her killer left her apartment he believed that he had gotten away with rape and murder. He believed no one would know he had hit her in the head stabbed Tara Stratton to death and mutilated her body by cutting off her breast. He believed that no one would suspect him, not even his wife and son. Who would believe he raped and murdered his son's girlfriend? Well, Mr. Alfred Brochu, 50, got a rude awakening when police handcuffed him and took him to jail to answer for the rape and murder of Tara Stratton. March 12, 2003 Alfred E. Brochu, 50, was charged with aggravated murder. Police were told by the state lab that the person who raped and murdered Tara Stratton was not her ex-boyfriend (he volunteered his DNA as did several other males who were her friends) but someone closely related to the exboyfriend, like a brother or a father. Mr. Brochu was a sex offender. Alfred Brochu served time in prison for raping a teenager in 1990 and he was charged with molesting a child in 1997. Law enforcement authorities in Vermont are required to protect the privacy rights of released sex offenders as a matter of law, so it was not widely known Mr. Brochu was a sex offender. Tara Stratton did not know her boyfriend's father was a sex offender. We do not image her exboyfriend discussed his father's criminal history with Tara Stratton.

There were two obstacles that the defense could not overcome in the 2004 trial of sex offender Alfred Brochu. A white truck was seen leaving the apartment building where Tara Stratton lived (he drove a white truck) and DNA evidence taken from her body matched a male relative of her ex-boyfriend; a close male relative. People may want to ignore the science of global warming but the fact that our genetic makeup comes from two individuals, a person's father and mother, is irrefutable. Mr. Brochu had run out of schemes and lies. There was no plausible explanation of how his DNA was found at a murder scene and he was at work during the time the DNA was deposited. The DNA came from seminal fluid not a cheek swab. A DNA match is not an opinion it is a fact. Mr. Brochu luck had run out. He had assaulted a woman making her disrobe. He was never prosecuted because the woman was too terrified to testify. He had assaulted other females and was only mildly inconvenienced by the justice system. His petty successes bolstered his believe that he could kill and get away with it. October 23, 2004 after hours and hours of deliberation a Vermont jury declared Mr. Alfred Brochu guilty of the first-degree murder of Tara Stratton. Lead prosecutor Cindy Maguire had convinced the jury that Mr. Alfred Brochu was guilty and should serve out the rest of his life in a Vermont prison. He was found guilty of aggravated murder. The murder was committed during another felony, the rape. Vermont has mandatory sentencing laws for aggravated murder. Alfred Brochu stabbed Tara Stratton in the heart and lungs and then cut off her breasts. Vermont murder convictions are automatically appealed. March 7, 2008 the appeal was heard and the appeal was denied. Now Mr. Brocchu will spend at least 30 years before he dies repeatedly telling his wife and son that he is innocent he is not a rapist and a murderer. Let us see how long his wife and son can stomach the lies. The death of Tara Stratton has caused many people to say the Vermont's Sex Offender Registry Law should be changed to provide more information to the public. The jury did not know any of his history, that Mr. Brochu sexually assaulted a 15-yearold girl in 1991. The jury brought back a verdict based on what they thought the evidence showed.

However shocked you may be by the murder of Tara Stratton it is a common occurrence for a female to be attacked by male relatives of their boyfriends or ex-boyfriends or their brother in laws. Uncles have raped and murdered their nephew's girlfriends and ex-girlfriends. Men have raped and murdered their wives' sisters and mothers. Brothers have helped one another rape and murder and dispose of bodies (Cook brothers). The fact that the father of her ex-

boyfriend decided to act on his impulse should not shock you. He lived a despicable life. His mind was a sewer as noted by the murder of Tara Stratton. It is when we do not think ill of some of our fellow men is when we get in trouble. The world teaches men should discriminate based on race when actually men should discriminate based on conduct. People who lie cheat and steal who break the law however slight have character flaws and those flaws can lead to rape and murder. This is why if your fiancés' family is corrupt it is better to find another fiancé. Finding the right partner for you takes self-control. If your boyfriend's mother sells drugs how can you marry him. She will want to babysit your children then what. If your boyfriend's father is a pimp how can you marry your boyfriend? You could never leave your children around their grandfather. If you notice corrupt behavior in a family walk away. In this book you will read about several men helping their buddy abduct a woman off the street. The men did not rape or murder the woman they just helped their buddy abduct the woman. Character flaw! Visiting a buddy at a dope house is a character flaw. Allowing someone to smoke marijuana in your car is a character flaw. Driving with someone that is going to pick up some dope is a character flaw. The father of Tara Stratton's ex-boyfriend had character flaws any behavior was permissible to him. This is why knowing the moral fiber of your boyfriend's family is just as important as knowing your boyfriend. If you observe corrupt behavior, find another boyfriend. Some of the women we discuss were raped and murdered by their boyfriend's relative that was a convicted rapist. In fact one woman was killed by her ex-boyfriend's uncle shortly after the uncle got out of prison. The police working that case would not let the case go. They were determined to find the killer. They poured over the evidence of hours interviewing and re-interviewing people in the area where the child's new car was found. Finally they spoke to a person who saw a man walking away from the car. The child was 18 years old just like Tara Stratton. She had everything to live for just like Tara Stratton. She should be alive today just like Tara Stratton. This is why we say the next time you look in a man's face you will realize how great the possibility is that you are looking into the face of a rapist because the number of rapists in the country is growing. Not all men are rapists, but we know that the vast majority of rapists are men. Any time you look into the face of a man you must realize you are looking into the face of a rapist. We do not care if the man is White; the young and White kill as often and with as much frequency as the old and Black. Nothing precludes a man from being a rapist. Nothing! Any time you look into the face of a man you must realize you have a 100% chance of looking into the face of a rapist. This is a lifesaving assumption. To think counter to this assumption is to put your life in that man's hands. Accepting this fact may save your life or you can avoid being raped.

Cases in point: July 30, 2013 San Diego Mayor Bob Filner asked the City Council to cover his legal bills in in the sex harassment lawsuit filed against him by a former aide. Later Lisa Curtin, the director of government and military education at San Diego City College, became the eighth woman to accuse the mayor of unwanted sexual advances. Friday August 16, 2013 former New York Yankee outfielder, Chad Curtis, 44, was convicted in Michigan of (fondling) sexually assaulting (second, third and fourth-degree criminal sexual conduct) three underage girls between the ages of 13 and 16 in 2012 while serving as a substitute teacher and weightroom strength trainer coach at a Lakewood, Michigan high school. He can be sentenced to a maximum of 15 years in prison. August 17, 2013 Natheer Abdul-Razzaque and his brother, Hashim, of Columbus, Ohio responded to the screams of a woman. Leanna Whitlock was found stabbed 50 times with a screwdriver and a butter knife. She was repeatedly raped by David Hudson, a family friend who was staying with her husband after recently getting out of jail. Whitlock told police Hudson forced her to perform oral sex several times, as well as stabbed her, punched her, and attempted to suffocate her with a pillow. David Hudson also reportedly told Whitlock if she did not comply, he would kill her. After the ordeal Mrs. Whitlock said, "He didn't ruin my life because I won. I beat him, he didn't kill me. "I want to make sure that he never gets

out, he never sees the light of day again." Mr. Hudson was held on a \$1.5 million bond. August 23, 2013 a Goldman Sachs managing director was charged with raping a 20-year-old woman while vacationing in the Hamptons. The incident allegedly took place in a four-bedroom home that Jason Lee, 37, rented with his wife. Police responded to a disturbance call from the home. His lawyer says his client is an "investment bank managing director who has never been in trouble in his life, never accused of any impropriety at all."

We again repeat the phrase you have a 100% chance of looking into the face or a rapist every time you speak to a man. It does not matter if this man is your father, brother, cousin, uncle or grandfather, or whether the man is a uniform police officer or a fireman. Every time you speak to a man you have the possibility of speaking to a rapist as testified by the number of women listed as raped and murdered in this book. When Margaret Lynn Eaton of Georgia looked into the face of Maurice Henderson she was looking into the face of the man that would later raped and murder her. He was a sex offender from Ohio hired by someone in her organization to work as a house parent at the Georgia juvenile detention center. You do not know the history of the people working around you so you should be cautious. A thorough background check should be made of anyone working around children and a thorough background check should be made of any male you are dating or any male you may be around for any length of time. This was not done and Ms. Margaret Lynn Eaton lost her life December 26, 1984. Any time you look into the face of a man you must realize you are looking into the face of a rapist. We do not care if the man is White; the young and White kill as often and with as much frequency as the old and Black. Nothing precludes a man from being a rapist. Nothing! Any time you look into the face of a man you must realize you have a 100% chance of looking into the face of a rapist. This is a lifesaving assumption. To think counter to this assumption is to put your life in that man's hands.

Nothing precludes a man from being a rapist or a murderer. Nothing! Any time you look into the face of a man you must realize you have a 100% chance of looking into the face of a rapist. This is a lifesaving assumption. To think counter to this assumption is to put your life in that man's hands. Accepting this fact may save your life. When you look in the face of your neighbor, coworker, cousin, grandfather, brother, father, or husband, you have a 100% chance of looking in the face of a person who will rape or kill you. This phrase applies to the judiciary and law enforcement as well. Oklahoma police officer Daniel Holtzclaw was convicted December 2015 for rape and sodomy. He was accused of raping 13 black females during traffic stops. One woman he raped while she was handcuffed to a hospital bed. One woman was a 57 year old grandmother. 6-foot-2, 260 pounds Daniel Holtzclaw was an Eastern Michigan linebacker that graduated in 2010. He was sentenced to 263 years in prison. He cried in court like the women he raped cried. One woman (the grandmother) said he did not have the right to rape her. She is the one who turned him in and fought until he was arrested. He forced his penis into her mouth after forcing her to remove her clothes and knell on the ground at 2 am. She was driving home after playing dominoes with a friend. He preved on Black women wonder why. His fellow officers who arrested him said after each rape he got bolder. He raped a 17 year old on her mother's front porch. The more than 12,000 women we researched make this statement true. If you value your life you will act accordingly. Most footballers get away with their rapes because so many people ignore the situation. Sasha Menu Courey, a University of Missouri swimmer, was allegedly raped by one or more members of the Missouri football team in 2010. Courey told a rape crisis counselor, a campus therapist, a nurse, two doctors, and an athletic department administrator that she was raped. Yet nothing happened. Not one footballer was disturbed. How much do you want to gamble that these men shall graduate and go on to manage a Fortune 500 company? These footballers will leave campus telling one another "we're safe. We're in the clear. Don't worry, three months from now the world will forget all about her; besides everyone thinks she is crazy anyway. She was not a reliable person. She wanted attention. We're safe."

Every time you speak to a man you have the possibility of speaking to a rapist as testified by the number of women being raped and murdered in this country. Any time you look into the face of a man you must realize you are looking into the face of a rapist. We do not care if the man is White; the young and White kill as often and with as much frequency as the old and Black. Nothing precludes a man from being a rapist. Nothing! A man's heights, his weight, the shape of his head, his hair color his shoe size or his race does not determine his proclivity to rape. Any time you look into the face of a man you must realize you have a 100% chance of looking into the face of a rapist. This is a lifesaving assumption. To think counter to this assumption is to put your life in that man's hands. Two cases in point - In 1985 Bennie Adams of Ohio was dating Gina Gay Tenney's neighbor. What no one knew is Mr. Adams was watching Ms. Tenney. He continued his surveillance of her until he was able to enter her apartment where he raped and murdered Gina Tenny. It was reported October 7, 2014 in the article '7th Heaven' Dad Stephen Collins Admits to Molesting Underage Girl, Fallout Reaches Hollywood, by Suzy Byrne that actor Stephen Collin confessed to his now ex-wife that he molested an underage girl and expose himself to two others.

Human behavior does not follow the predictability of a roll of the dice therefore we say, the next time you look into the face of a man you must realize how great the possibility is that you are looking into the face of a rapist because the number of rapists in the country is growing. We are all not the same. Not all men are rapists, but we know that the vast majority of rapists are men. Any time you look into the face of a man you must realize you are looking into the face of a rapist. We do not care if the man is White; the young and White kill as often and with as much frequency as the old and Black. Nothing precludes a man from being a rapist. Nothing! We can prove this statement. Any time you look into the face of a man you must realize you have a 100% chance of looking into the face of a rapist. This is a lifesaving assumption. To think counter to this assumption is to put your life in that man's hands. Accepting this fact may save your life or you can avoid being raped. When you look in the face of your neighbor, coworker, cousin, grandfather, brother, father, or husband, you have a 100% chance of looking in the face of a person who will rape or kill you. There are no exceptions. The conviction of Colonel

Russell Williams, a top commander in the Canadian Air Force, of rape and murder and the conviction Thomas McCarthy, 44, a well-known firefighter of Fairview Park, Ohio, for rape is proof of what the Institute says that every time you look into the face of a man you have a 100% chance of looking into the face of a rapist. There are no exceptions. Make an exception lose your life.

Chapter 15

The University

You need to know who is living and working around you. You must be interested in the invisible workman, the illusive neighbor or the boyfriend who visits and sometimes stays overnight in the apartment above you.

In this chapter we discuss the murder of the female student. The student is a special victim because they do not expect violence they believe they are in one of the most secure environments in the world, the university campus. These women had their hopes and dreams destroyed because of the murderous act of one or two people lurking in the darkness. Their murders took place from 1974 to 2010. The women were killed by parolees, rejected suitors, ex-boyfriends, boyfriend, during burglaries, by drug addicts convicted rapists men out on bond. Many of their cases are unsolved. In some situations we did not list the injuries to the body. We just accept you will understand the murders were horrific committed by men who planned for years the murder of a woman.

Every year thousands and thousands of children leave home traveling across the country to attend a university for four years to bring change into their lives. Attending a university is a very important time spent for personal development. Children arrive at college campuses to attend class and to work hard. They have hopes and dreams. They spend their every waking hour considering the right thing to say, the right thing to do anything that will bring them closer to realizing their aspirations. Students are people interested in changing the world, making a contribution, joining the peace corp. looking for cures to rare diseases. Yet regardless of all their hard work there is a person lurking in the darkness ready to destroy that dream at a moment's notice.

Some of these young women you may recognize because laws were written in their name. What would be nice is the tremendous reduction in the number of students being murdered across the nation rather than having laws written in their names. More information should be given to student during maturation cautioning the young to the dangers that can be found on university campuses. Students should be told over and over again that they represent a portion of the populous that is viewed as the perfect prey along with the aged and the infirmed. We are only offering a brief overview of these murders. Some of the testimony during the trials is mind boggling because the first question you ask yourself is how someone can be so stupid. One man testified he kidnapped a student, with the help of another man who he did not name, but he did not kill the student. In one case the assailant said that the woman was shot because she sprayed him with mace. He shot her while she was fleeing. He escaped on his bicycle. In some cases the assailant said the drugs made them do it in other cases the assailants were angry or troubled. We offer this chapter because we believe more should be done to protect the young in society. More can be done to stop the robbery and murder of students across this nation. We must do more to protect one another.

Adrienne Salinas, 19

Adrienne Salinas, a Gateway Community College student, from Tempe, Arizona was reported missing June 25, 2013. She attended a party where she left around 4 am after a fight with her boyfriend. They continued to argue until she left for home. The two front tires on Ms. Salinas car blew out just a couple of blocks away from her apartment. She called a cab company at

5:05 a.m. June 15, 2013. When the cab driver arrived he was unable to find her. Her body was found in Apache Junction August 6, 2013.

Aimee Willard, 22 (See Maria Cabueno)

Aimee Willard lived in Brookhaven, Pennsylvania. She was a college athlete at George Mason University. Aimee Willard was a lacrosse and soccer player. She was a senior. She was kidnapped June 20, 1996 from her car, raped beaten with a tire iron and murdered. She died of blunt force trauma. Her body was found in a factory in North Philadelphia. Her assailant saw her in a bar when she was meeting friends. He followed her from the bar and used traffic accident to force her out of her car. Murderer Status: Arthur Bomar, 31, a 1979 parolee from Nevada, was arrested June 6, 1996 for burglary. Information given to the police made him a suspect in the murder of Aimee Willard. Although he said he was innocent he pled guilty to murder. His girlfriend, Mary Rumer, testified in court he admitted to her that he kidnapped Aimee Willard. He originally tried to use his girlfriend to provide him with an alibi for the time of the murder. His girlfriend refused to help him. Arthur Bomar was found guilty October 2, 1998. Aimee Willard's mother said she was thankful for the guilty plea because she did not want the details of her daughter's murder discussed in court. When Arthur Bomar was apprehended he was driving Maria Cabuenos' car, another missing woman from Philadelphia. May 30, 2003 the Pennsylvania Supreme Court has upheld the conviction and death sentence of Arthur Bomar. The lower court was ordered to resentence him for the conviction of for kidnapping, rape and abuse of corpse. The laws (repeat offender's law) governing the sentencing for these convictions was later ruled unconstitutional. Mr. Bomar was a bold killer.

Alexandra Kemp, 19

Never disregard scratches on a man's face or body!

Friends and family called Alexandra Kemp, Ali. Ali Kemp was beaten to death in 2002 at a public pool where she worked by a little man who believed no one would suspect him that he would never get caught. He could not pass up the opportunity because he was alone with the victim and he thought no one would know. Murderer Status: Benjamin Appleby, 31, pool maintenance man, arrested November 8, 2004. December 5, 2006 he was convicted in a Johnson County Kansas court house of capital murder and sentenced to LWOP for 50 years. He is another stupid man. No one is around so I can kill and no one will know it was me. Now he has 50 years to consider his decision. At age 81 he can leave prison if he is able to walk. Mr. Appleby lived in Connecticut. He killed in Kansas. No one was supposed to know but Ali Kemp's father persisted in his pursuit of her assailant. He posted the composite drawing of her killer everywhere. Mr. Benjamin Appleby was identified from that composite. See how stupid his thoughts were? No one was supposed to know. Ali Kemp was a Kansas State University student.

Alexandra Kogut, 18

Alexandra Kogut was a freshman student attending the State University of New York in Brockport, New York. She was beaten to death in her dorm room during the week end of September 28, 2012. She died from a severe trauma to her upper body. Clayton Whittemore, 21, was arrested while driving back to Utica College. He told police he caused Miss Kogut's death but pleaded not guilty to murder. The two were dating. Campus police found the body after Alexandra Kogut's mother could not reach her by phone. Mr. Whittermore was convicted

but not to life in prison. Some day he will be paroled. He had a history of violence against his girlfriends.

Alice Johnson, 25 (The assailant is still at large) Allen Wesley Alexander, 34

Alice Johnson and her boyfriend, Allen Alexander, were students attending Laney College in Oakland California. Police believe they were robbed and abducted then murdered April 13, 1992 to prevent their identification of the assailant. Murderer Status: unknown

Alice Mayfield, 20 (Her assailant is still at large)

"When I buried my daughter, I buried a part of my soul and a part of my soul is in the graveyard with the dead." Bessie Mayfield, mother

Alice Mayfield was a student at the Wichita State University. She went to a New Years Eve party in 1988 to celebrate. She was murdered during the celebration. She was strangled to death then her body was placed in a storage room. Her assailant had tried to rape her. She refused his sexual advances so he murdered her. Murderer Status: unsolved

Alicia Corey Manning, 22,

Alicia Corey Manning was a senior student attending California State University in Bakersfield. She was three weeks away from graduating when she was raped, robbed and stabbed to death in her apartment May 20, 1997. Mr. Willie Leo Harris was convicted of all charges with special circumstances allowing him to be sentenced to death August 24, 1999. His death sentence was upheld by the appeals court. Alicia Manning and her boyfriend were preparing to move back to her home state where she had a job waiting.

Alicia Showalter Reynolds, 25 (Her assailant is still at large)

Alicia Reynolds had just graduated of Goshen College. Alicia Reynolds was driving from Baltimore, Maryland to Charlottesville, Virginia when she disappeared March 2, 1996. She was on her way to meet her mother. Her abandoned car was found on the shoulder of U.S. 29 South in Culpeper County in Virginia. Her remains were found May 7, 1996 off State Route 3 in Lignum. Murderer Status: unknown as of 2010.

Allison Myrick, 19

Allison Myrick was from Groton, Massachusetts. She was a Fitchburg State College freshman. Allison was studying journalism and graphic design. She was brutally murdered January 23, 2010. Her throat was slit and she was shot between the eyes with a pellet gun, and a cigarette was extinguished on her body as a final insult. She was murdered by Robert Gulla, her exboyfriend, just days after she filed a restraining order against him. Gulla and Myrick met at a college party and had been dating for only four months before he killed her. Robert Gulla had abused Allison Myrick throughout their relationship. During this time Robert Gulla punched Allison in the stomach, pushed her, choked her and then tore her cell phone out of her hand when she was calling a friend for help. He sent her harassing text messages, once he repeatedly punched Allison in the stomach. He assaulted her because he was angry she was not following his orders that forbid her from texting other people. Four days before Myrick was killed, Gulla was calling and texting her incessantly. In 2012 Mr. Gulla was convicted and

sentenced to life in prison without parole. Now he will live with men who are just like him men who will kill at a moment's notice. In 20 years let us see how angry Mr. Gulla will be.

Alyson Ilene Kaplan, 20

Alyson was attending college in California but decided to take a foreign vacation then return to school and complete her degree. She worked three jobs and saved up enough money because she wanted to visit Italy, England and Holland.

Mrs. Alyssa Heberton Morimoto, 24

Alyssa Morimoto was a geology graduate student attending the University of Colorado working on her master's degree in environmental science. She was interning with the Colorado Geological Survey when she was murdered June 26, 2007. She was working in the Pike-San Isabel National Forest in Park County Colorado mapping the geology of a ridge in the forest. A parolee living in the area at a camp ground was later charged with her murder. He was released in 2001. He strangled Alfred F. Bronson, a music teacher, during a burglary in 1981 in Kansas. Mr. Robert R. Amos, 44, alias, Dennis Lee Cook was charged with first degree murder. She had recently married. We do not see Mr. Amos in prison in Colorado. He may be in federal system. He may have died of cancer.

Amanda Teresa Stavik, 18 assailant at large

Amanda Stavik was freshman at the Central Washington University. She came home to Whatcom County, Washington for the Thanksgiving holiday. She was an avid jogger and everyone in the area knew she jogged every day. November 24, 1989 she left home with her German shepherd to go jogging. That was the last time she was seen alive. When she was reported missing searchers went out and found her body along the bank of the Nooksack River. Her assailant has never been apprehended. Amanda Stavik's goal was to be an aircraft pilot or some profession where she could help others.

Amie Montgomery 19

Amie Montgomery was a student attending the Wichita State University in Kansas. She was a recipient of a Wallace engineering scholarship. Friends and staff said she was an excellent student. She was a founding member of the Student Ambassador Society (SAS). Like so many young people found Amie Montgomery found her a job in a sub shop. The job was fairly simple and would allow her to work the hours she wanted, plus the relax atmosphere lent itself to young people. She was murdered February 17,1997during a robbery. In 1998 by her family and the Student Ambassador Society created the Amie Montgomery Student Ambassador Society Endowed Scholarship in her memory. Amie Montgomery was characterized by her Christian manner and her concern for people. Murderer Status: Dominic Pearson was convicted of one count of conspiracy to obstruct commerce by robbery and one count of obstruction of commerce by robbery and one count of carrying or using a firearm during and in relation to a crime of violence resulting in the murder of a person through use of a firearm. He was sentenced to 240 months for each of the § 1951 violations and 360 months for the § 924 violation.

Amy Blumberg, 20

assailant stranger

Amy Blumberg was working part time in a dance supply store.in O'Fallon, Illinois. She was a student of a college in O'Fallon, Illinois trying to earn some extra money. She was a junior at Easter Illinois University. New Year's Eve, December 31, 1999 a man entered the store and killed her. She was shot in the head. Her parents found her partially-clothed body in the restroom of the store in 2003 Edward Phillips, 37, was charged with murder. Bond was 1.25 million. He was finally convicted and sentenced to 55 years in prison.

Amy Quinton, 22

Amy Watkins 26

"My hope is that whatever happens to this David Jamison, there will be at least some opportunity for him to change down the road. We think that would be a real credit to Amy, and a credit to what we think of being human.

Lawrence Watkins, father

Amy Watkins lived in Brooklyn, New York. She was stabbed to death with a kitchen knife while walking home from work March 8, 1999. She was robbed. Murderer Status: unknown – Mr. David Jamison and Felix Rodriquez were charged with murder. Mr. David Jamison trial for first-degree murder began May 7, 2001. Miss Amy Watkins was a student of social work. The two men said they decided to rob Miss Watkins when they saw her walking down the street alone. They stole her purse and said she backed into the knife one of the men was holding. Two men accost a woman on the street for a purse that they have no idea how much money is inside the purse, and now they both will have the opportunity of spending at least 15 years in prison. Their action was beyond stupid. Amy Watkins graduated from the University of Kansas in 1996, and was a student at the Hunter College School of Social Work at the time of her death. Both institutions established scholarships in her name

Anarae Schunk, 20

Anarae Schunk was a junior studying sociology at the University of Minnesota. She was reported missing 2013. She was last seen alive on September 22. Her body was found September 30, 2013. She was stabbed to death. Her jacket had 20 puncture marks. Her jacket was found in a St. Paul, Minnesota apartment that belongs to her ex-boyfriend, Chavez-Nelson's former wife. Authorities believe Ms. Schunk left the bar with her ex-boyfriend. She was trying to get back the \$5,000 she had loaned him prior to their breaking up. It was by chance she witnessed her ex-boyfriend commit a murder. June 2014 Shavelle Oscar Chavez-Nelson and his current girlfriend, Ashley Conrade were charged with second degree murder. Chavez-Nelson and Ashley Conrade were charged in the 2013 the shooting death of Normandale Community College student Palagor Jobi outside of a grill in Burnsville, Minnesota. The investigation determined that both Ms. Schunk and Ashley Conrade were with Chavez-Nelson at the time of this shooting. Anarae Schunk is believed to have been killed in Ashley Conrad's apartment because she saw this shooting.

Angelina Sicola, 20

Angelina Sicola was a sophomore attending the University of Colorado, in Colorado Springs. She was majoring in communications. She worked at the US Taekwondo Center in Monument.

Angelina's body was found in her apartment May 2, 2013. She was strangled to death. Case is unsolved. The family is offering a \$10,000 reward

Andrea Del Vesco, 21

Andrea Del Vesco was a student attending UCLA. She was a member of Pi Beta Phi. She was a fourth-year psychology student. She was young pretty healthy and enjoying life until someone murdered her in her apartment September 21, 2015. September 17, 2015 prosecutors charged Alberto Hinojosa Medina and Eric Marquez, both 22-year-old students, with the murder of Ms. DelVesco's, saying Medina broke into Ms. Vesco's apartment and stabbed her after burglarizing a nearby apartment. Alberto Medina and Eric Marquez face charges including murder, arson and burglary in the death of Andrea DelVesco. Alberto Medina set the house on fire when they left the apartment. Ms. DelVesco's property was later recovered from Medina's home in Fresno. He was seen on a surveillance camera. The men pleaded not guilty. The bond set at \$1.1 million. Medina is a junior at Fresno State University, where he was studying psychology and social work. Special circumstance makes him eligible for the death penalty if convicted. Witnesses and forensic evidence connects him to the crime. Medina faces the death penalty. See how a simple idea and completely destroy one's life. All we have to do is break into an apartment and steal their stuff and sell it. Simple! Easy! Sell the goods and we will have plenty of money. Easy! Ms. DelVesco was stabbed at least 19 times.

Andrea Faye Wills, 18

Where did the fury and anger come from?

"We're devastated. There's no sense to it. "She was just the kindest person."

Dain Meyer, uncle

"She just bloomed. She was incredibly happy. She loved college."

Julie Tack, cousin

"It seems a little odd when he wouldn't let go of that (relationship). But "there was no expectation of anything violent. We trusted him." Julie Tack, cousin

"He's one of the most morally sound people I've ever met. He was always taught to respect women. I couldn't see him doing anything like this."

Tom Dixon, friend of Justin Boulay

"It's an unbelievable shock none of his friends can believe it. It's just not Jay. He wouldn't do it. He wouldn't hurt a flea." neighbor

Andrea Wills lived in Coles County while attending the Eastern Illinois University as a freshman. She was found strangled to death February 1998 in another student's apartment. She was murdered after trying to break off her two year relationship with a fellow student she had dated. Murderer Status" Justin J. Boulay, 20, he became a stalker. He would not let go. February 3, 1998 he was charged with murder. He pleaded not guilty by reason of insanity. There was no doubt to his guilt. He called his mother and told her what he had done. His mother notified the police. Andrea Wills was pledging at the Sigma Kappa sorority and was an honor student well-liked by many. He took all this away from her. She died three days before her 19th birthday. During Mr. Boulay's trial two psychiatrists testified. Dr. Daniel Cuneo said he acted "knowingly when he murdered Andrea Wills. He was conscious and knew he was choking her at the time. He was not psychotic, he wasn't mentally retarded. He was never so seriously depressed that

he couldn't understand that what he was doing was wrong." There was no disorder of thought." Dr. Terry M. Killian said, "Depression is not a substantial disorder of thought that would impair his ability to know or control his behavior." Forensic psychologist, Dr. Jerry Boyd, said "I do not believe the depression at that time would render him unable to appreciate the wrongfulness of his actions." In other words Mr. Justin J. Boulay deliberately strangled Andra Wills to death because he wanted to. Neither professional would absolve him of his guilty. March 1999 Coles County Judge Ashton Waller found Mr. Boulay guilty of first-degree murder. "It is clear to me that there is no real question that Mr. Boulay did strangle Andrea Wills."

Mrs. Andrea Hayslette 29 (Her assailant is still at large)

Andrea Hayslette lived in Horry County South Carolina and was a Coastal Carolina University student. She has been missing since 1993. Her husband was accused of murdering her and running to West Virginia. Murderer Status: Larry Hayslette was extradited to November 1996 to stand trial for murder. The charges were dropped for lack of evidence. Her body has never been found. Mr. Hayslette remained incarcerated on other charges.

Andrea O'Donnell, 27

Andrea O'Donnel was a student at the San Diego State University and was the director of the Women's Resource Center in California. She was strangled to death November 1994. Murderer Status: Her boyfriend and drug user, Andres English-Howard, 31, was charged with her murder. August 10, 1995 Mr. Howard was found guilty of murder. October 9, 1995 he hanged himself in his cell before being sentenced. The resource center was renamed in Andrea's honor and a scholarship fund was started in 1995.

Andrea Robyn Goff, 22 Sheri Helene Goff, 19 Mark Richard Aldridge, 30 Mr. David Marc Goff, 46 Alyse Renee Goff, 14

Andrea Robyn Goff was a recent graduate of Washington University in St. Louis. She was a class mate of Melissa Aptman. She was active in volunteer programs and was an honors student with a double major in philosophy and English literature in our College of Arts and Sciences. She returned home to Maryland before completing further studies. She planned to start law school at George Washington University in the fall. July 20, 1995 she was murdered along with her father, David and sisters, Sheri and Alyse, in her home in Potomac, Maryland. Each of the victims was beaten, their bodies found bound and gagged in separate rooms. A painting contractor, Mark Richard Aldridge, 30, was also murdered. Sheri Goff was a sophomore at the University of Maryland College Park. Murderer Status: Ecuadoran handyman, Bruman Stalin Alvarez, 20, was charged with five counts of first-degree murder. Mrs. Goff and her son were on vacation elsewhere. A friend said Bruman Stalin Alvarez was angry with Mark Aldridge over money owed him. July 27, 1996 Bruman Stalin Alvarez, 21, was sentenced to six consecutive life terms after he admitted that he killed his boss and four members of the Goff family and the rape of Alyse Goff. This was the longest sentence ever handed down in Maryland. The rape was the cause for the murders. Alyse Goff was rape while others were away when they returned each was bludgeoned with a hammer.

Andrea Walness, 18 (Her assailant is still at large)

Andrea Walness was a Virginia Tech student sophomore living in Blacksburg, Virginia. She was originally from Woodbury, Connecticut. She was a gymnast and a hiker. July 4, 1991

Andrea Walness and three friends go to the New River near McCoy, Virginia for a day of tubing. She is separated from the group. Her remains were found in a laurel thicket 1991 by a hunter.

Angela Brock, 29 (mother of 4)

Angela Brock lived in Miami, Florida. She was the mother of four children. She was working and attending Broward Community College. She wanted to become a paralegal. Her children were left in the care of the Think Lifes Pelude day care center. February 1998 Ms. Brock was stabbed to death in front of her children after she arrived at the day care. Odette Green, a volunteer, stabbed her after the two women argued over Green's treatment of Miss Brock's child. Odette Green thought she had the right to discipline Miss Brock's 4 year old son by pulling his ears and pinching him. Apparently the day care center did not instruct Odette Green to the proper way to discipline a child. The child was probably humiliated and extremely hurt by this type of treatment that he told his mother as soon as she arrived at the center. Odette Green was found guilty of second degree murder and sentenced to 20.5 years in prison. She filed an appeal May 1999.

Angela Samota, 20

Angela Samota was a student attending the Southern Methodist University in Houston, Texas. She lived in a condominium off campus. The body of Angela Samota was found in her apartment in 1984. She was raped and stabbed repeatedly. The man who raped and murdered Angela Samota was paroled in March 1984 after being convicted of raped in 1977. He killed Angela Samota October 13, 1984. He was paroled in 1984 because he behaved himself in prison. This man was not charged with her murder until 2009. He was in prison for raping another woman June 14, 1985 when he was charged with Angela Samota's murder. Donald Andrew Bess Jr., 69, was convicted and sentenced to death June 2010. Two women testified at Mr. Bess's trial that he had also raped them. Mr. Bess found himself tired of prison so he appealed his conviction and sentence. April 13, 20156 The Texas Court of Criminal Appeals refused appeal. Mr. Bess us now 67 years old

Angelika Denise Williams, 21

Angelika Williams lived in Dekalb County Georgia. She was a licensed cosmetologist who moved from Washington to Georgia to go to school. Angelika just completed the Medical Assistant Program at the Stanford Brown Medical Institute in Atlanta, Georgia. January 11, 2009 her body was found in her car slumped over the steering wheel. Her murder case remains unsolved.

Anita Knutson, 18

Anita Knutson was an absolutely beautiful young woman, gorgeous in appearance living in North Dakota. She was a Minot State University student majoring in Elementary education. She worked three part time jobs to pay for her education. June 4, 2007 her father found her stabbed to death in her off campus apartment. Anyone with information about the murder of Anita Knutson is asked to contact the Minot Police Department at (701) 852-0111. The family has also created a "Justice for Anita" "If somebody has a tip, think something is important, or they thought something was a little out of place, it doesn't hurt to share it with us, and follow up on it to try and see if it goes anywhere."

Anita Mathews was a sophomore at Central State University in Xenia, Ohio. She was studying marketing. She was home for the holidays visiting family and friends in Detroit, Michigan when she went out on a date November 14, 1992 with an old friend name, James Sharpley Jr. James Sharpley knew Anita Mathews was coming home. He went to work to buy a used 1979 Chevrolet so he could take her out on a date. James Sharpley used the last of his money to purchase the car. Their date was supposed to be special. The date turned disastrous when Frederick Windmon, 24, accosted the couple with an Ak47. Angry because the couple did not have any money he shot them both in the back of the head as they lay on the ground. He drove off in Sharpley's car. Murderer Status: Frederick Windmon was charged with two counts of first-degree murder, first-degree rape and armed robbery. It seems Mr. Windmon has accosted another couple November 8, 1992. For this crime he was charged with first-degree rape and robbery. We do not see a conviction. Disposition unknown

Channon Gail Christian, 21 Hugh Christopher Newsom, Jr. 23

"You reward a child for good behavior. You don't reward a murderer for good behavior."

Terry Smith, mother of a murder victim

Try as I may I have not been able to write about the death of this student. Channon Christian's death and the death of her boyfriend, Christopher Newsom, January 6, 2007 is unfathomable. It upsets me every time I look at the picture of her and her boyfriend. Their smiles were so full of life. You can see the joy in their eyes. Channon's folder has been in my computer for almost ten years and I have refused to open it and read the contents. I keep asking myself how did society created such creatures that participated in these murders. Where did these people come from? Channon Gail Christian was a University of Tennessee student out on a date January 7, 2007 with her boyfriend, Christopher Newsom. They were carjacked from the road taken to a home where they were raped, tortured and finally murdered. Both were sexually assaulted. Four people participated in this debauchery. Vanessa Coleman, 18, Lemaricus Davidson, 25, his brother, Letalvis Cobbins, 24, and George Thomas, 24, were all tried and convicted of rape murder and kidnapping. Their convictions were overturned because of the conduct of the judge. Vanessa Coleman was sentenced to 35 consecutive years in prison with parole eligibility after 41/2 year. She should not be paroled. Judge Blackwood said the crimes were so horrific they outweigh any mitigating factors. "This is a horrible crime. Horrible, senseless, cruel-- every word you can use to describe this event," said Blackwood. "This is the most horrible I have seen, and I've seen some horrible ones in my lifetime." A family member said, "I cannot find it anywhere in my heart or my soul, written or spoken anywhere, where you deserve mercy. My family has now sat through two trials. It amazes me how two attorneys could come up with so many excuses when there is none, both times guilty, not by 12 people but 24. Gotta figure some way there's some guilt." Lemaricus Davidson is on death row where he should be but his brother, Letalvis Cobbins, escaped the death penalty he is serving life in prison without parole along with George Thomas. Eric Boyd who helped the men get away is serving 18 years in federal prison for carjacking. In Tennessee a person can get 16 days per month (192 days per year) shaved off his or her sentence for good behavior. This statue accelerates the rate in which Vanessa Coleman will be eligible for parole. Five men and one woman participated in the destruction of two beautiful people. Apparently, Ms. Coleman wrote about her escapade in Tennessee. She called it an adventure saying she had fun over that weekend. Vanessa Coleman was up for parole December 2014. The families of Channon Gail Christian and Christopher Newsom knew one another. They had hopes and dreams of the future of a wedding and grandchildren. These dreams are no longer

Ann Marie Courtney, 28 (Her assailant is still at large)

Ann Courtney was a San Jose State University student. She was a Botany major. She loved to take nature walks. She went missing October 1985 in the Big Sur wilderness. Miss Courtney was last seen by other hikers on Oct. 25, 1985. Soldiers from Fort Ord and the Monterey County sheriff's deputies used helicopters and dogs to search for her. Her skeletal remains were found January1, 1988.

Ann Pfreundschuh 21

Ann Pfreundschuh was a student at Pratt Institute in Brooklyn, New York campus. She was murdered in her apartment during a robbery November 1983. She was bound, beaten then drowned in her bathtub. Murderer Status: Anthony Wright and Carlton Brown were charged with her murder. They were convicted October 1, 1984.

Annie Le, 24

On September 9, 2009 Annie Le, a Yale graduate student, was raped and strangled to death while at work. Her body was found stuffed behind a research laboratory wall on September 13, 2009, five days after she had last been seen inside the Yale medical building. Raymond Clark III, 24, an animal research assistant who worked in the same facility, was arrested by police September 17, 2009 and charged with the murder. After a plea agreement Mr. Clark pleaded guilty and was sentenced to 44 years in prison. Mr. Clark had the same impish heart and mind as Mr. Oliver Travis O'Quinn, the nurse that poisoned Michelle Herndon, 19, a student at University of Florida. Ms. Herndon was rapidly approaching graduation where she and her boyfriend were to marry and leave for the peace corp. This is why the NISV says every time you look into the face of a man you have a 100% chance of looking into the face of a rapist. There are no exceptions. Raymond Clark worked in the lab with Annie Le all along he was thinking filthy thoughts. The rape was not a spur of the moment event; he planned the rape for days. He knew how much time he needed to rape and to conceal the body. The attack on Annie Lee had nothing to do with love or admiration. On September 9, 2009 Annie Le, a Yale graduate student, was raped and strangled to death while at work. Her body was found stuffed behind a research laboratory wall on September 13, 2009, five days after she had last been seen inside the Yale medical building. Raymond Clark III, 24, an animal research assistant who worked in the same facility, was arrested by police September 17, 2009 and charged with the murder. After a plea agreement Mr. Clark pleaded guilty and was sentenced to 44 years in prison. Asia McGowan, 20

"My daughter was a sweet, talented young lady who treated people beautifully. She has been in movies and was on her way up." mother

Miss Asia McGowan of Ecorse, Michigan wanted to be an actress and a choreographer. Her Facebook page was filled with her dreams. She began to pursue her career by attending theatre classes at Henry Ford Community Colleges. Asia McGowan was shot to death April 9, 2009 by a fellow student, Anthony Powell, 28. The two were class mates they were not

romantically involved. Mr. Powell had a history of irradiate conversation, wanted to commit suicide and expressed a distain for women. He used a shot gun to kill Ms. McGowan then shot himself. Her dreams of becoming a choreographer and actress died with her.

Aundria Crawford 20 (See Rachel Newhouse)

"The two girls are dead. If I'm not a monster, then what am I?"

Rex Allan Krebs, registered sex offender

Aundria Crawford was a student attending Cuesta College in San Luis Obispo, California. She was a sophomore designing student. She was kidnapped from her home March 11, 1999. After several days of searching the police said they believed she was dead and another missing student was also dead. Aundria Crawford was missing six weeks before her body was found. Friday, April 23, 1999 a body (Rachel Newhouse – missing for five months) was found near the home of the man the police believed is a murderer. The police are holding the man in jail on a parole violation of March 20, 1999. The man is being held because alcohol was found in his home. Murderer Status: Rex Allan Krebs, 33, was a convicted rapist became the prime suspect in two murders. He was convicted of rape of a woman in Oceano, California and attempted rape in Arroyo Grande in 1987. Mr. Krebs was on parole from Idaho for auto theft when he committed these crimes. He left Idaho and moved to Grover Beach, California in March 1987. Shortly after he arrived in California he raped a woman. He attempted to rape another woman in May 1987. October 1987 he pleaded no contest to rape, sodomy, assault with intent to commit rape and burglaries. He was sentenced to 20 years instead of 30 years. He was convicted but paroled after serving 10 years in prison. Needless to say he was not rehabilitated. April 24, 1999 a second body was found on the property where Mr. Krebs was living. This was the body of Aundria Crawford. She was missing six weeks. It was reported May 7, 1999 he was charged with two counts of murder and kidnapping, three counts of rape, one count of sodomy and one count of burglary. These charges were resulted from a parole officer being curious. Approximately two years later, on May 11, 2001 Mr. Krebs was found guilty of two counts of murder. The jury recommended the death penalty. We do not know if the judges in California have to follow the recommendation of the jury. Mr. Krebs frequented a lounge near Miss Crawford's home. Please note Mr. Krebs, a registered sex offender, moved into the San Luis Obispo area around September 1998 three months later Miss. Newhouse is reported missing. Notice the pattern. Mr. Krebs is a thief, commits rape shortly after moving into area, is incarcerated, is paroled, moves into an area returns to his old habits but this time he commits murder he does not want to return to prison. Mr. Krebs also had a girlfriend. She was pregnant at the time of his arrest. Please note the number of murderers discussed whose behavior follows the same pattern. At first the men are burglar or burglars and rapist after a prison term they are burglars and murders and the burglaries and murders begin shortly after the men move into the neighborhood and the men have a female liaison.

Avnita Ghuman

Avnita Ghuman of Roswell. Georgia was a Kennesaw State University Student. Avnita Ghuman body was found late afternoon, September 14, 2006, in the trunk of her car, along a logging trail deep in the woods of Cherokee County west of Canton, off Georgia Highway 20. The two men charged with disposing Ghuman's body are 20-year-old Eric Robert Martinez of Acworth, and 21-year-old Alan Bryant Whitman of Acworth. They were charged with Improper Disposal of a Body, Concealing a Death, and Tampering with Evidence.

Ayesha Thomason, 18

On June 16, 2009 Ayesha Thomason, 18, a Merritt College student, of Oakland, California was shot to death. Jesse James Blue, 21, also a student, was arrested on suspicion of murder. Ms. Thomason was trying to end the relationship. They dated for six months. After a six month relationship he decides to kill. Why was he carrying a gun? Where did he get the gun? August 2011 a jury convicted him of voluntary manslaughter rather than second-degree murder. He will serve 21 years in prison. The prosecutor showed he had a history of anger toward Miss Thomason and had beaten her twice during their nine-month-long relationship. Jesse Blue was a basketball player. He said the shooting was accidental let us see who he shoots the next time once he gets out of prison.

Barbara Ann Derry

Barbara Ann Derry was a Clark College student from the Goldendale, Washington area. She was last seen hitchhiking February 11, 1972. March 29, 1972, a body was found at the Old Cedar Creek Grist Mill in a remote, wooded area in northern Clark County. The woman died of a single stab wound to the heart with a narrow bladed instrument. The body was identified April 3, 1972 as Barbara Derry. She had not been reported missing. Her murder case remains unsolved.

Beth Akers, 20

Beth Akers lived in Springfield, Illinois. She was attending Springfield College in the area. April 9, 1988 Tommy Lee Coleman, 20, and DeeArlise Childrous, 19, decided to rob someone. They happened upon Beth Akers around 11 pm she was standing outside a friend's home when the two men grabbed her purse. Rather than just running one of them shot Beth Aker, once in the stomach and once in the thigh. She died during surgery. Tommy Coleman was convicted of armed robbery and murder. His sentence will be 20 to 60 years in prison. His accomplice, DeeArlise Childrous is subject to the death penalty. He is the one who actually shot Beth Akers. Coleman was prosecuted on the theory that he is legally accountable for Childrous' actions. Two women implicated the men in the crime.

Betsy Foster, 21

"We don't feel this was fair to us or our daughter. It's too long for us to have to suffer like this."

Helen Foster, mother

"We thank the judge for his decision. But we're numb. It's been so many years."

Richard Foster, father

Betsy Foster lived Gainesville, Florida. She was a college student that was beaten to death March 15, 1992. Her murder investigation has been marred by the lack of cooperation of Wisconsin. In 1997 Florida authorities were told that a prisoner in Wisconsin who was convicted of rape bragged about murdering Betsy Foster. When the state of Florida indicted George Taylor and asked for extradition they were rebuffed. Her murder has never been solved. Murderer Status: George Taylor, 29, has been accused of her murder. But he is being aided by the state of Wisconsin. He will never appear in a Florida courtroom to answer to the charge of murder. Here we have a state acting as the defense attorney. The state of Wisconsin has refused to extradite George Everett Taylor to Florida. If he did not murder Betsy Foster let him prove it in court. One of the witnesses is dying of bone cancer. One witness is in Beijing, China. The evidence is deteriorating. The situation is absolute camouflage. Wisconsin is not a capital

punishment state. Florida is a capital punishment state. If convicted Mr. Taylor would face capital punishment in the state of Florida. (Remember the situation that existed between Texas and New York. Texas convicted a man of murder and sentenced him to death. New York sentenced the man to prison. New York wanted the man returned so he could spend time in their prison rather than the person being executed in Texas.) Wisconsin is a **parole** state. They parole their murderers. Wisconsin is a kissing cousin to Michigan. Michigan, Indiana, Illinois, Wisconsin and Ohio share convicts. Someone from Wisconsin made this statement regarding the situation between Florida and Wisconsin. "The issue is pretty simple for us. The state of Wisconsin has an obligation to the Lacrosse, Wisconsin victim To make sure that this person serves his sentence here." Right! so he can be paroled and come visit the citizens of Michigan. June 7, 2001, after four extradition hearings Mr. George Taylor will be extradited to Florida to answer for the murder of Betsy Foster. Witnesses identified Taylor as the man seen near Betsy Foster in a Gainesville, Florida park March 15, 1992, the day she disappeared. He was living in Florida when Foster's nude body was found in a shallow grave eleven days after she disappeared. In 1996, Taylor was arrested in Wisconsin in the kidnapping, sexual assault and beating of a college student in La Crosse. Image if Illinois had treated California with such distain when they wanted to extradite Andrew Urdiales for the murders of four California women. Or Florida refused to extradite Mr. Rogers to California for murder.

Bonnie Craig, 18

Bonnie Craig was a freshman attending the University of Alaska in Anchorage. She left home September 1994 walking to the bus stop to attend an early morning class. She was abducted raped and then beaten to death. Her alleged murderer remained hidden for thirteen years. After a DNA match was made Kenneth M. Dion, 38, was extradited from a New Hampshire prison and charged with rape and murder. He could not be charged with kidnapping because the statute of limitation had run. His trial is pending. He was incarcerated in New Hampshire for a robbery conviction. He was eligible for parole. Mr. Dion is now under the authority of the Alaska Department of Corrections. At the age of 40 he has begun serving a life sentence. Image lying on your bed in prison knowing you will sleep in a tiny cramp space for the rest of your life.

Bonnie Jean Garland, 20

Bonnie Jean Garland was a senior attending Yale University. She tried to end her two year relationship with her boyfriend, Richard James Herrin, 23. She studied music and became interested in another young man she met on a European tour. Bonnie Garland was bludgeoned to death in her home in Scarsdale, New York July 8, 1977 while she was sleeping. She was assaulted in her bedroom. Mr. Herrin was allowed to stay in the home while on vacation. Her parents were sleeping when the attack took place. Murderer Status: Richard James Herrin was arrested for murder. He was the proverbial boyfriend. Before pleading innocent of murder, Mr. Herrin told the police his plans were to murder his girlfriend then kill himself. Like so many men he never got around to killing himself. Money was collected on campus to use for his defense. During Mr. Herrin's 1978 trial his attorney said he suffered from a temporary mental defect and extreme emotional disturbance. In his confession he said he murdered Bonnie Garland because he did not want to be without her. Ms. Garland was blamed for her murder. Mr. Herrin was pictured as naïve and unsophisticated and Ms. Garland was presented as outgoing and a woman of the world. How could Mr. Herrin hope to cope? The New York State Appeals Court unanimously upheld the conviction of Mr. Richard Herrin June 22, 1981

Brandee Whitehead lived in Pascagoula, Mississippi. She was a student at Auburn University in Montgomery. January 12, 1998 she was found stabbed to death and her 2 month old daughter, Abrani Whitehead, missing. Her boyfriend was ruled out as a suspect. His daughter was not with him. Murderer Status: Latashia Taylor, 22, and Aubrey Cornelius Cathcart, were arrested January 14, 1998. Abrani was recovered unharmed. Both were charged with kidnapping. Ms. Taylor is charged with capital murder and Mr. Cathcart is charged as an accessory. Ms. Taylor was convicted and sentenced to life in **prison without parole**. Ms. Whitehead was stabbed and cut 151 times with two kitchen knives. Mississippi has the death penalty.

Brandie Danielle Davis, 19

Brandie Danielle Davis, 19, of Statesboro, Georgia was strangled to death December 8, 2009 in her apartment. She was attending Georgia Southern University. Her murder remains unsolved until December 22, 2009 when Daryl Anthony Priestley, 17, was arrested. Priestley pled guilty December 2010 to charges of murder, tampering with evidence, and false statements. He was sentenced to life plus 10 years. Priestley will have to serve a minimum of 30 years before he can be parole eligible. "It's brought a sense of closure to us," said the grieving mother, on hearing Priestley's fate. "I didn't feel anger towards him," Garcia said. "I didn't feel bitter. I almost felt pity for him, because he didn't have anybody. I feel bad for him. There was nobody there for him. "All parents can empathize with what I went through and what I will continue to go through," she continued. "[But] I forgave him a long time ago. I hope he can, somehow, make a difference inside the prison system." Stephanie Garcia, mother. Priestley was a student at nearby East Georgia College at Statesboro. They knew one another from high school.

Brandy Steven-Rosine, 20

Two women participated in the murder of Brandy Rosine. What they did to Miss Rosine is beyond description yet the Meadville, Pennsylvania prosecutor said he cannot seek the death penalty. Hopefully he can ask their juries for the maximum sentence of life in prison without parole. Brandy Rosine was a sociology student at Youngstown State University. She once dated one of her assailants either, Ashley Marie Barber, 20, or Nichole "Jade" Olmstead, 18. May 17, 2012 the two women lured Brandy Rosine to their home where in the woods they attacked her. We will not discuss how she was killed. Miss Rosine was reported missing by her family. Her body was found in a grave near the defendant's home. The women are charged with one count each of criminal homicide, conspiracy to commit criminal homicide and tampering with physical evidence. They had no problem telling the police how they killed Brandy Rosine.

Brianna Zunino Denison, 19

Brianna Denison was a psychology student at Santa Barbara City College. She disappeared January 20, 2008 while on a winter break after partying with her friends who attended the University of Nevada in Reno. The police believe she was abducted while sleeping on a friend's couch. Blood was found on a pillow she was using. She is described as white, 5-feet, 98 pounds, has long dark brown hair and blue eyes. In 2008 there were over 1,700 registered sex offenders in the Washoe County. Remember our calculation of the number of rapist per square foot. A reward of \$100,000 was offered. The abduction of Brianna Denison proves there is always someone watching. Several women were raped around the time Brianna Denison was abducted. The Washoe County sheriff said there was a DNA backlog at the county's crime laboratory. The legislature recently passed a law requiring all convicted felons and convicted

sex offenders to submit DNA for inclusion in the national data base. Close to \$93,000 was received from citizens to clear the backlog. Ms. Denison's body was found February 15, 2008. When the forensic evidence taken from the scene and rape kits was matched to the DNA evidence taken from the assailant's son (reverse paternity test) Mr. James Michael Biela, 27, was arrested. Mr. Biela had a job, a girlfriend and a son. He is suspected of three rapes and one murder. The police asked for any sexual assault victims who had not reported incidents to come forward. This information would important if any if the victims were assaulted by Mr. Biela. The police learned of Mr. Biela when a person called and suggested him as a possible suspect. Mr. Biela was charged with raping a woman at gun point October 2007 and raping a woman November 2007. Michael Biela is awaiting trial. He was convicted May 2010 and sentenced to death June 2010.

Brittany Morgan, 22

Brittany Morgan was a 22 year old attending the University of Southern Mississippi in Hattiesburg, Mississippi. She had everything to live for but she made one mistake she began dating a man with a man with no ambition who was too old for her. Her body was found in her apartment February 23, 2011. She was beaten and stabbed multiple times. Her boyfriend, Anthony Rico Gipson, 36, was arrested 6 hours later and capital murder and attempted kidnapping. When he was arrested he threatened to kill himself by holding a gun to his head. What do you know his courage failed him? He did not want to die; a coward to the end. Actually he was cornered and did not want to shoot it out with the police. Brittany Morgan's family said Mr. Gipson was controlling. He did not like her talking on the phone. Now we shall see how many people he can control while in prison.

Brittany Phillips, 18 (Her assailant is still at large)

Brittany Phillips was a sophomore student of Tulsa Community College living in or near Tulsa, Oklahoma.

She was raped and strangled to death in her apartment September 27, 2004. To date her murder has not been solved. There is a possibility that her assailant has murdered before but his DNA has not been entered into the state or CODIS databases because of a backlog. His DNA may not be available because all states do not require any one arrested for a felony to provide DNA

Brittany Sue Zimmermann, 21 (Her assailant is still at large)

Brittany Sue Zimmerman was a junior student attending the University of Wisconsin. She was beaten and stabbed to death in her apartment April 2, 2008. She made a 911 call to the police but the call went unanswered. Apparently the dispatcher did not hear anyone on the line and dismissed the call. Apparently Ms. used a cell phone and only land line phone calls are followed up. A reporter (David Schoetz) broke the story May 2, 2008 Student's 911 Call Falls on Deaf Ears Outrage After Newspaper Exposes Slain Wisconsin Student Called 911 Without Response Please order this article because you need to know how 911 calls made from cell phones or land line are answered in your state. Her murder has not been solved.

Brooke Carol Wilberger, 19

Brooke Wilberger was attending the Brigham Young University in Provo, Utah but was home for the holidays when she was murdered May 24, 2004 in Benton County, Oregon. She was last seen cleaning lampposts in the apartment complex parking lot where her sister and husband were managers. The man convicted of her murder made a plea agreement with the police to avoid the death penalty. He agreed to reveal the location of her body. Ms. Wilberger was abducted from her apartment, bound, raped then bludgeoned to death. Her attacker, Joel Courtney, 42, is still alive today living in a New Mexico prison. He pleaded guilty to aggravated murder and received a life sentence without the possibility of parole. Yes Mr. Courtney was a registered sex offender. He was arrested for abducting and raping a woman in New Mexico. We do not know the disposition of the New Mexico case as to why he was not convicted. His targets were college students

Caitlin McGuire, 24,

Caitlin McGuire recently moved to Franklin Township, Pennsylvania. Caitlin McGuire was a graduate student at Marywood University. She died February 6, 2011 when she was shot in the head in her home. Earlier she told a friend over the phone that she had been arguing with her boyfriend, Matthew Brokenshire, 24. Murderer Status: Pittston Township police officer, Matthew Brokenshire, 24, attempted suicide by shooting himself. He died at a local hospital. Caitlin McGuire died at the scene. A friend found their bodies. The couple had been dating for about 10 months and knew each other for years. Officer Brokenshire just began working as a police officer. He was well liked. His superiors were disturbed at the suicide because he showed all the signs of being a respectful and orderly officer.

Caitlin Nichole Walter, 21

On May 13, 2009 Caitlin Nichole Walter, 21, of Indianapolis, Indiana was shot to death in her home. Her ex-boyfriend **committed suicide**. She was a student at Indiana University-Purdue University of Indianapolis and at the University of Indianapolis. She was studying to be a Physical Therapy Assistant

Candice M. Harms, 18

Candice Harms was a freshman attending the University of Nebraska- Lincoln. She was kidnapped from the streets while walking her home her boyfriend's home. Her body was found December 1992 she had been missing since September. Murderer Status: Scott Barney and Roger Bjorklund were convicted her rape and murder. Roger Bjorklund was sentenced to death. He died in his cell of a heart attack. Scott Barney was sentenced to life in prison. He was a follower. Candice Harms lived in Minnesota.

Carla Marie McKishnie, 22

Eleanor Anne Grace, 20

"Now we find we're just having to survive every day. Holidays are nightmares for us. Just a day to try to make it through with the pain that we're having to bear without Anne. The simplest joys in life aren't there anymore."

Susan Grace, mother

Eleanor Grace and Carla McKishnie were University of Florida students and roommates living in an off campus apartment. The two young women were murdered in their apartment June 6, 1991. The only version offered for the murders was given by the defendant. No one really knows what happened in the apartment. Murderer Status: Alan Robert Davis, a local carpet cleaner, was charged with murder. He was reported to their home to clean the carpet. He left the home a murderer. Mr. Davis was found guilty of murder. The prosecutor asked for the death penalty. The judge said no. Circuit Judge Robert P. Cates sentenced Mr. Davis to

consecutive life sentences. This sentence precludes the possibility of parole. Alan Davis' defense attorney said Mr. Davis came from a dysfunctional family, had an untreated emotional problem and that the murders were not premeditated

Carly Raquel Martinez, 18

We apologize to our readers but the story of Carly Martinez is not a story of her death it is the story of one of her alleged murderers, Mr. Desnoyers. It is the story of his lack of character and human weakness. It is the story of a pitiful, wretched man who in his entire life never stood for anything. When reading Mr. Desnoyers' testimony you are faced with the fact that this is a young man who has never taken responsibility for his life. His testimony reminds you of the wretched human being who sat by when Betty Osborne was murdered in Canada. Who trained this man? Who was his father? Where was this man's courage.? This man's testimony was a reflection of the way this man lived. Where was this man's pride and where was his dignity? Carly Martinez was a New Mexico State University freshman. She was home on a Christmas break in El Paso, Texas when she was stabbed to death in 1998. She was stabbed more than 30 times. She met two men in a bar January 14, 1998. By the end of the night she is murdered and two men participated in the cover up of her murder. We have tried several times to write about the death of Ms. Martinez but we keep coming back to the lack of moral training and courage. Murderer Status: Jason Desnoyers, 24, was tried in Albuquerque, New Mexico for first-degree murder, conspiracy and evidence tampering. He was convicted of life plus 34 year in prison. Mr. Jesse Avalos Jr., 26, was also charged with murder. In 2000 he was convicted of life plus 63 years in prison. He told the family he was sorry. Mr. Desnoyers testified July 22, 1999 that after partying and drinking in several Las Cruces bars Mr. Avalos met Carly Martinez. The group left the bar and drove to an isolated area where he went to sleep inside his truck and left Carly Martinez and Mr. Avalos alone. When he awoke he saw Mr. Avalos standing over Carly's bloodied nude body and Mr. Avalos told him he better help cover up the murder or Mr. Avalos would kill Mr. Desnoyers' family. So Mr. Desnoyer helped to bury Carly's body and destroy the bloody clothing etc, then he went on his merry way trying to forget the incident. Why did he not go to the police and tell his story? If he did not participate in the murder of Carly Martinez, why did he not have enough personal strength and fortitude to go to the authorities and tell them his life and the life of his family had been threatened. At least this would have been an act of standing up. Two stupid men!

Carmela Fuce, 18

Her assailant was sentenced to death

Carmela Fuce was living in Tallahassee Florida attending A & M University as an engineering student in Fort Lauderdale. She was attending a famous college in a town most talked about for its treatment of students. Carmela Fuce was living her dream. She was strangled to death in her apartment in 1991. Murderer Status Richard Tony Robertson, 20, was charged with robbery and capital murder. A jury found him guilty in 1993 and recommended he be sentenced to death. He was using drugs and alcohol the night he committed the murder. His attorney sought to use his drug use a mitigating circumstance to lower the crime to second-degree murder thus saving his client's life. He did not succeed. Carmela Fuce rented the apartment while waiting for a room in the dormitory. We believe he is still alive.

Mrs. Carmen Gabriella Tortora Gayheart, 23 (mother of 2)

Carmen Gayheart lived in Fort White, Florida. She was a nursing student at Lake City Community College. She was poised to graduate when she was abducted August 27, 1994 from a parking lot and murdered by two parolees. She encountered two escapees as she left a convenience store. One parolee was in prison for armed robbery the second parolee was in prison for attempted murder. Neither of these men should have been released early. Both men, Anthony F. Wainwright and Richard E. Hamilton are now on death row. All appeals have been exhausted so they should be nearing execution. Richard Eugene Hamilton and Anthony Floyd Wainwright, kidnapped her took her to an area where they raped and strangled her then shot her twice in the head. Richard Hamilton was convicted of First-Degree Murder, Armed Robbery, Armed Kidnapping, and Armed Sexual Battery. He was sentenced to death for the murder of Carmen Gayheart and to life imprisonment on the other convictions. Mr. Wainwright was sentenced to death June 12, 1995. Where did they get the gun? Now two children are motherless. The murder of Mrs. Carmen Tortora Gayheart is one reason why the death penalty in this country will always be revived time and time again. Regardless of how awful the thought is of an innocent man being executed the thought of men like Richard Eugene Hamilton, 32, and Anthony Floyd Wainwright, 24, sitting in prison for the rest of their life after brutally raping and murdering a woman is overwhelming. Mrs. Gayheart lived in Lake City, Florida. April 27, 1994 she was on her way to pick up her two children from the day care when she encountered two escapees in a parking lot looking for a car to steal. Carmen Gayheart was abducted from the lot taken to an area where she was raped and murdered. June 12, 1995 a Florida jury said the men should die for their actions. The judge concurred. In Florida a jury can override a jury's decision with respect to the death penalty. A Florida judge can sentence a person to life in prison without parole rather than death. Circuit Court Judge E. Vernon Douglas decided the men should die. The two men sat and discussed how they were going to kill Mrs. Gayheart as she sat nearby after both men had raped her. They deserve to die. Mrs. Gayheart was attending a nursing school close to graduating.

Now two children are motherless.

Carol Ann Barrett, 18 (Her assailant is still at large)

Carol Barrett a college student from Zanesville, Ohio was in Florida on vacation. She and seven other people were robbed in their hotel room. She was kidnapped and later found murdered in Daytona Beach, Florida in 1980. She was shot to death. Murderer Status: unknown.

Carol Gray

Carol Gray was a Lindenwood College graduate student studying in Missouri. She was robbed and murdered in <u>a secluded area</u> of a parking lot November 1987. Murderer Status: Creston Austin, 41, was charged with second-degree murder and armed criminal action. He was found guilty in 7 hours July 1989 by a jury of seven women and five men. He was sentenced to two concurrent life sentences. He was eligible for parole in 15 years. He was denied parole in 2000. Austin insisted that he had shot the student, Carol Gray, in self-defense as they struggled over her handgun in the front seat of Gray's car. He was convicted of second-degree murder because he fired a second shot into her chest. The jury believed the second shot was fired to kill.

Carrie Arlene Williams 20

Bessie Lawrence,

She was a Pittsburg State University student studying fashion merchandising in Kansas. She was raped, sodomized then stabbed to death in her home March 29, 1996. She was the

second student murdered in three years. She was beaten, choked and stabbed to death. She was stabbed seven times. Murderer Status: Gary W. Kleypas, 40, a nursing student, was arrested April 1, 1996 in Springfield, Missouri. He had fled to Missouri after the murder. January 24, 1977 he was convicted of second degree murder in Galena, Missouri. He had broken into the home of Bessie Lawrence, his neighbor. He raped her then beat her to death. He was sentenced to 30 years in prison. He served 15 years. He was paroled and entered the nursing program at Pittsburg State University. Carrie William's father questioned how a convicted rapist could be enrolled on campus with his past and why wasn't he properly supervised by the parole office. Mr. Kleypas had a warrant out for his arrest for a 1994 rape charge. Why wasn't Mr. Kleypas returned to prison based on this warrant? Also once the police began investigating they learned Mr. Kleypas made threatening and obscene phone calls to Ms. Williams anomalously. In 1997 Gary W. Kleypas was found guilty of the murder of Carrie Williams. August 5, 1997 a Kansas jury sentenced Mr. Gary Kleypas to death. He now has the distinction of being the first man sentenced to death in Kansas since the death penalty was reinstated in 1994. A Forensic psychiatrist said Gary Kleypas murdered Carrie Williams in a planned way, with a clear presence of mind. The rules for who can be admitted to the nursing program at the university were changed and who can be issued a nursing license by the state was changed due to the death of Carrie Williams. Mr. Gary Kleypas should have never been around unsuspecting females. Mr. Kleypas was a convicted rapist. No woman knowingly would be in close proximity of a rapist. Carrie Williams died because a social experiment went awry. It is a known fact that convicted rapists reoffend. Their lives are dedicated to violating women. Also it is know that certain age groups are targeted by sexual predators Look the number of women murdered on campus across the country and the number of women ages 16 thru 19 who are murdered. In 2002 Mr. Kleypas was waiting for the penalty phase of his trial to be revisited. The Kansas Supreme Court overturned his sentence. The court said the law was improperly applied and he must be resentenced. He was not executed and we do not see him in prison. Remember we said neighboring states share in crimes committed their parolees.

Carrie Lynn Yoder, 26 see Chapter 10 page 281

Cassondra Brown, 18

Cassondra Brown lived in Portland, Oregon. She was a student of the Portland Community College. She was strangled to death and her body was dismembered January 4, 2003. Her remains were later found in Long Beach, Washington. Murderer Status: January 14, 2003 her ex-boyfriend, Benjamin Karl Cramer, 18, was charged with murder. He said he was not guilty. March 20, 2003 he pleaded guilty to murder and first-degree abuse of a corpse. Because of the deal brokered for him he will serve a minimum of 25 years old prison. He will get a second chance at life. Cassondra Brown was her parent's youngest daughter.

Catherine Elizabeth Kelton, 21

Catherine Kelton was a student attending East New Mexico University. She was robbed and murdered in 1993. Ms. Keltong was found strangled and drowned in the bathtub. Murderer Status: Tommy Wayne Willis, 26, of Tulia, Texas, was charged with second degree murder, aggravated burglary, aggravated robbery and false imprisonment in 1993. December 8, 1997 he pleaded guilty. April 3, 1998 he was sentenced to 28 years in prison. He will be 54 years old when he leaves prison young enough to start life over. Catherine Kelton was struck on the head with a beer bottle while in her kitchen. She was then dragged into the bathroom, put into the

bathtub, and strangled with the sash of her bathrobe. Catherine Kelton will never get a second chance at life.

Catherine John, 21

Phyllis Peppin

Catherine John was a junior attending the St. Cloud State University in Minnesota. She worked at a pizzeria to earn extra money. Unknown to her she was working alone with a sex offender who had ideas of rape and murder. Catherine John was raped and murdered October 27, 1980 after reporting to work. She was stabbed 21 times outside of the building where she worked. Mr. Charles Lee LaTourelle was convicted of her murder. His defense was he was mentally ill. Please note this is a common occurrence for women to be killed by coworkers. Keep reading. In 1999 an unsolved murder was cleared when Mr. LaTourelle confessed to the murder of Phyllis Peppin in Arden Hills, Minnesota when he was 17 years old. Mr. LaTourelle delivered papers to the home of Phyllis Pepping. During this time he became obsessed with her. In 1972 he broke into her home to commit the act of rape when Ms. Peppin resisted by running away from him, Charles LaTourelle shot her to death. He was not a suspect in the crime before his confession. We have reported on other paperboys who have killed.

Catherine Schilling, 21

Catherine Schilling was a of 21-year-old Georgetown University student. Ms. Schilling was raped and murdered June 1981 while walking home from work. She was shot in the head. Catherine Schilling was found raped and murdered in Rock Creek Park in Washington, D.C. She was nude and had been shot five times in the head. Donald Eugene Gates was charged and convicted of her murder September 16, 1982. He was freed December 15, 2009 after DNA evidence proved he did not commit the murder. Why he was convicted is a great question. How was he selected for this murder? Her murderer was free to rape and murder for 28 years. When Mr. Gates left prison he was given a bus ticket to Ohio and \$75.00 to live on. He had to pay \$25.00 for a cab ride to get to the Greyhound station from the prison. Gerald Mack Smith, a police informant was paid over \$1000 to provide his testimony that Mr. Gates confessed to him of the rape and murder of Catherine Schilling. The prosecution said the hairs taken from Ms. Schillng's body were microscopically identical to sample taken from Mr. Gates, which is a lie. The FBI agent who over saw this case was discredit and proven to have lied on a death penalty case in Florida. FBI Special Agent Malone, a forensic analyst, testified that Gates' hairs were "microscopically indistinguishable" from hairs found on the victim's body. Malone testified that in twelve years of examining hairs for the FBI, there were only two occasions out of ten thousand where the hairs from two people could not be distinguished. He went on to imply that based on his experience, the hair from the crime scene probably belonged to Mr. Gates. It turned out that despite the fact that Mr. Malone was with the hair unit throughout the 1980's and 90's, regardless of the year, he routinely testified that he had examined the hairs of 10,000 people in his career. An FBI serologist also gave false and misleading testimony, effectively neutralizing what appeared to be an exclusion. A 1997 review by the Justice Department discredited the work of that FBI analyst, Michael P. Malone, and 13 other analysts, finding that they had made false reports and performed inaccurate tests. In 1997, an internal review of the FBI laboratory found that Malone and other analysts made false and misleading reports on cases across the country and in numerous instances, their lab notes did not support their reported and testimonial conclusions. In January, 2002, the U.S. Justice Department sent a letter to prosecutors in the case, informing them that Malone's lab report was not supported by his notes and advising them to determine whether Malone's hair testimony was material to the conviction. The real perpetrator was identified through the DNA profile of the semen recovered post mortem. The real perpetrator had worked as a temp at the office building of the victim and

had followed her home when she left work. By the time he was identified, he was decease. Think of all the innocent men sent to prison based on erroneous testimony. To add insult to injury Mr. Gates was sent to a prison far beyond the reach of family members, to Arizona of all places. Arizona's economy is based off of housing black and poor white prisoners. The Washington Post reported that the jury found two metro homicide detectives concocted all or part of a confession they claimed Gates made to a police informant. The Washington Post also wrote the investigators also withheld other evidence from Gates. Andy Silverman of the Arizona Justice Project worked on Mr. Donald Gates' behalf. If the FBI has corrupt people working for them, what chance does an innocent man have in this country? Ms. Schilling worked as a paralegal at a DC law firm. For 28 years her parents lived with the idea that a ravenous Black man murdered their child and destroyed their future. The processing of information is important to the justice that is meted out in this country. April 13, 2017 Attorney General Jeff Sessions announced he is ending an Obama-era partnership with independent scientists that aimed to improve the reliability of forensic science, as longstanding concerns remain about the quality of such evidence in court cases. The Justice Department will not renew the National Commission on Forensic Science, a panel of judges, defense attorneys, researchers and law enforcement officials that had been advising the attorney general on the use of scientific evidence in the criminal justice process. The department will instead appoint an in-house adviser and create an internal committee to study improvements to forensic analysis, Sessions said. Their tasks will include a broad look at the personnel and equipment needs of overburdened crime labs.

"As we decide how to move forward, we bear in mind that the department is just one piece of the larger criminal justice system," said Sessions in a statement, adding that most forensic science is done by state and local laboratories and used by local prosecutors.

The Obama administration formed the commission in 2013 to address wide-ranging concerns about problematic forensic techniques. The Justice Department also is reconsidering an effort launched last year to review forensic sciences practiced by the FBI. That review sought to determine whether other scientific disciplines have been tainted by flawed testimony, a problem that surfaced in 2015 when the Justice Department revealed that experts had overstated the strength of their evidence in many older cases dating back decades involving microscopic hair analysis. The disbanding of the commission was yet another way in which Sessions is shifting away from his Obama-era predecessors, who pushed for changes in forensic science and tried to establish federal standards. Last year, for example, acting on the commission's recommendations, the Justice Department announced a new code of professional responsibility for its forensic science laboratories and also cautioned its examiners and prosecutors to use restraint in discussing the strength of their findings, among other standards. Cathie Lynn Rauwald, 26

Timothy C. Regan 24

Cathie Rauwald and her friend, Timothy C. Regan, 24, were murdered May 14, 1987. Both were veterinary students of the University of Wisconsin. Murderer Status: Dr. Michael J. Person, 27, was charged with two counts of first-degree murder. The two students were murdered in his

home in McFarland. He was tried November 1988. Michael J. Person was a practicing veterinarian. He was in love with Cathie Rauwald but she did not return his affection. He sexually assaulted Miss Rauwald after he shot her. Dr. Persons was convicted December 1988 and sentenced to 35 years in prison. Dane County Circuit Judge Mark A. Frankel also ordered Person to serve a maximum sentence. He was supposed to be a friend and mentor to the two students as it turned out he became their executioner. This is why The Institute says every time you look into the face of a man you have a 100% chance of looking into the face of a rapist. There are no exceptions. Dr. Persons invited these two students to his home as a friend yet in his mind he desired Miss Rauwald and had decided to kill the couple and rape Miss Rauwald.

Cathy Torrez, 20 Her assailants were at large for 13 years

Cathy Torrez lived in Placentia, California. She attended the California State University and was on the dean's list.. She worked part time at the Sav-on Drug Store Pharmacy. Her body was found in the trunk of her car in the parking lot of the Placentia Linda Hospital February 19, 1994. She had been missing for more than a week since February 12 after leaving work. She was slashed to death across the neck and chest. She told a co-worker she was going to meet Sam Lopez. Ms. Cathy Torrez was on the Dean's list. Murderer Status: June 2007 two cousins, Sam and Xavier Lopez, both 35 were arrested and charged with murder based on DNA. Previously the two men provided one another with an alibi for the murder. Sam's brother Armando Lopez, 36, and Juan Barroso, pleaded not guilty to accessory to the murder charges. Cathy Torrez' mother introduced herself to every new police chief over the years recounting her daughter's murder.

Cathy Zimmer (Mother of 2) (Her assailant is still at large)

Cathy Zimmer lived in San Jose California. She was attending the San Jose State University and was excited about her life. She attended class the morning of March 10, 1989. Later that day her body was found in her car at the Mineta San Joes International Airport (miss direction). She was strangled to death. Murderer Status: unknown - remember Andrew Urdiales he murdered Robbin Brandley, a 23 year old California college student in the school parking lot, just before he returned to home after being discharged from the military. It took several years but he was finally connected to the murder.

Ceeatta Stewart McKinne, 23 pregnant

Ceeatta McKinne was attending a college in Richmond, Virginia. She was dating a married man. When she became pregnant he bludgeoned her to death in 2002 and left her body in the woods. Willis Edward Anderson was convicted of murder and sentenced to 50 years. Men who seek extramarital relationships are not always dissatisfied with their wives. Dating is just a recreation. No woman should hope to supplant a wife or believe that their pregnancy makes a difference to a married man. Note the number of pregnant women murdered by their lover. A man with a wife and children is not seeking an extra mouth to feed. Dating a single woman while married means he has other fish to fry and your relationship with him is not important. Some pregnant women were murdered just before the man married another woman. With all the men in this country why date a married man. A woman was murdered in Texas fifteen minutes after she threatened her married boyfriend. She told him she was going to tell his wife. Apparently he cared more about his wife finding out about the affair than he cared about her life. Dating a married man is like sitting in bathtub filled with rattlesnakes. How do you think you are going to exit the tub without be bitten. With a country filled with single men it makes no sense to date a married man illusion and all. There was another man living in the south he began dating his

daughter's best friend on the side. Everyone in the neighborhood knew this young lady went to his house often. They would see her walking down the street. Imagine the shock of his daughter and wife when they learned the young woman had become pregnant and he murdered her. If you want love and affection find it with a single man.

Chandra Johnson 17

Chandra Johnson lived in Detroit, Michigan. She graduated from high school successfully. She applied to Wilberforce College and was accepted. In 1993 she left home for Ohio to begin a 4year adventure of meeting new people and learning. August 31, 1993 she was murdered on the Wilberforce College Campus. Her ex-boyfriend shot her to death in the parking lot. When a woman is murdered and the assailant is the boyfriend or husband or ex-boyfriend or exhusband one thing is for certain the woman was correct in her opinion of the man she left. When Chandra Johnson decided to discontinue her relationship with her ex-boyfriend she was right on the money. He was no good. He was flawed. There was an imperfection in his character. Her boyfriend proved her right in her evaluation of him when he shot her. The fact he committed murder means he was a person without a character, a person without empathy and bent on revenge. He was self-centered and irrational in his thoughts and behavior. When men like Chandra Johnson's ex-boyfriend are tried in court it never comes out that clearly that the victim was right in their appraisal of the person they broke up with. Murderer Status: Ronald Dancy Jr. 21, drove to Ohio committed murder then drove back to Detroit and turned himself into the Detroit Police. I wonder if he knew the state of Ohio is a capital punishment state. Greene County Common Pleas Court Judge Thomas M. Rose found him guilty of aggravated murder and sentenced him to life in prison. He must serve 23 years before he see a parole board. To date he has served 16 years and 174 days in prison. This man was a fool. He took a life trying to make a woman do what he told her to do. We cannot find him in prison.

Charlotte Murray Pace, 22 see Chapter 11 page 133

Christel R. Helmchen 19

"The crime not only took our Christel, it destroyed our whole family The camaraderie just is not there now. We were five parts before, Acting as one unit, but now we are just four parts."

Judy Helmchen, mother

Christel Helmchen worked the midnight shift at White Hen Pantry. She was working at the convenience store to pay her tuition at Purdue University in Lafayette, Indiana. She was abducted from her place of employment taken to an abandon home raped and then murdered. Three men participated in her murder. Murderer Status: Perry S. Miller was an ex-convict who drove a delivery truck that serviced the store where Christel worked. He masterminded the abduction. He was found guilty of murder and sentenced to death. He has not been executed yet. He was also sentenced to 220 years in prison for the other charges. He fought his conviction and the death sentence all the way to the Indiana Supreme Court. Ten years later the court upheld the conviction and the sentencing. Mr. Miller should be dead by now since the murder took place in 1990 and his appeal was denied. He is alive he was removed from death row in 2001. Mr. Miller's step son and a friend were arrested in Kentucky. This is the statement the stepson, Mr. Rodney Wood gave to the prosecutor in order to escape the death sentence. Rodney Wood "admitted that he, Perry Miller, and his friend, William Harmon had discussed robbing the White Hen, and that Harmon told them he had found a remote place to take the clerk where they could rape her and kill her. Miller drove Wood and Harmon to the White Hen

and waited in the car while Wood and Harmon went inside, robbed the clerk at gunpoint, and escorted her to her car. Wood drove Helmchen's car and Miller followed to Highway #6. Harmon gagged and tied her and she was then dragged to a construction site. Miller fondled her, threw her to the floor and ordered Wood to have sex with her, which he did. Miller instructed Wood and Harmon to tie her upright to a wall and Miller beat her with his fists. Harmon struck her with the shotgun. Miller then beat her with a 2 X 4 and stuck her with an ice pick in the thigh and breast. Upon Miller's direction, Wood and Harmon retrieved a tire iron and inserted it into her rectum while Miller watched. Miller and Wood then walked to the car. Harmon followed Helmchen out, put the shotgun to the back of her head and fired." An ISP hair examiner identified pubic hairs from Miller on the body of the victim. William Glen Harmon,19, was also charged with Christel Helmchen's murder. He was the one who pulled the trigger. William Harmon was a friend of Perry Miller's step-son. His attorney dreamed up a brilliant strategy to avoid the death penalty for his client.

The defense attorney asked the presiding judge to allow his client to plead guilty to the charges before the judge but to be sentenced by a jury. Porter Superior Court Judge Roger V. Bradford said no. If Harmon wanted to plead guilty before a judge then William Harmon would be sentenced by the judge. Harmon's attorney appealed the judge's decision to the Indiana Court of Appeal. January 1992 the petition was denied. Harmon wanted to be allowed to murder but not to face the consequences of his act. November 3, 1992 he was sentenced to 280 years in prison. He should have been **sentenced to death**. He and the other men who participated in the murder of Christel R. Helmchen had no sympathy or remorse. All they wanted was to be able to get away with murder.

The third man present when Christel Helmchen was shot said he didn't protest when Christel was being tortured and shot November 14, 1990 because" it wasn't up to me." Apparently he thought he was not as guilty as the other two men. This man is somebody's son. Imagine a man standing in court and telling 12 people he watched a murder and whether that person lived or died was not up to him. In that one sentence he described his life. He was a man who lived his live day in and day out participating in acts he had no control over. This man's thought process boggles the mind. The man failed to realize the reason why he was in court for the murder of a young woman was because he lived a life of squalor. He became what the world calls poor white trash. This man said he participated in an act in which he did not have an opinion or control over. Men such as these do not belong on this earth.

Christel Helmchen casket was carried by pallbearers from the Valporaiso Porter City Police. The policemen got to know her while making their rounds.

Christina Burgin, 19

When Christina Burgin's rapist was executed May 10, 2002 her parents were present in the Louisiana prison. Her mother, Diane Godeaux, said, I'm ecstatic. I'm happy," Her father, Charles Burgin, said, "My smile says it all." It would be hard not to agree with her parents since they had to wait 11years to see their daughter's assailant executed. Christina Burgin, a college student at McNeese State University, was in a bar socializing with friends. She left the bar with 24 year old Leslie Dale Martin. June 20, 1991 was the last time Christina Burgin was seen alive. The next time anyone saw her was when her body was found. She had been raped her eyes had been gouged out, her throat was cut. She had been choked with a rope. Someone jumped up and down on a board placed across her neck. Leslie Martin was on parole for another sexual assault against a 14 year old.

Christina Samuel, 22 (one of 9 siblings)

"If someone would just imagine their baby sister being innocently gunned down. Never had an enemy or never harmed anyone, and imagine the devastation that the family is dealing with and they knowingly had some information that could help lead to an arrest or solve the case, it would be a no-brainer." Christopher Moore, 34, brother

Christina Samuel was on her way to graduate school. She was scheduled to start graduate school January 2015 at Indiana Tech in Fort Wayne. Samuel graduated from Indiana Tech in May with a bachelor's degree in criminal justice. Christina Samuel died December 25, 2014 after two men shot into the car she and a friend were sitting in on Carlisle Street in Detroit. Her friend was shot but survived. A \$2,500 reward was offered for information. Christina Samuel was shot multiple times and died at the scene.

Christy Ann Galvin, 26

Christy Galvin was a graduate of University of North Carolina-Charlotte. She was a volleyball star. She was strangled to death in 2005 less than a week after breaking up with her boyfriend. Her ex-boyfriend Seyi Tayo Odueso, 31, who was apprehended driving her car, was tried September 2009. It did not take the jury long to return a guilty verdict to second-degree murder. His defense to the murder charge was that Ms. Galvin attacked him with a knife and he strangled her with a towel to defend himself. The jury convicted him of the greater charge.

Cindy Lee Hudspeth, 29 see Chapter 11 page 133

Cindy R. Rounsaville, 25

see Margaret Everson Fossi, 25

Cindy Rounsaville was a Rice University student. She studied architecture. Her body was found in a field in Houston, Texas April 23, 1986. She was shot to death. A suspect was identified May 9, 1986 as John Kennedy Barefield, 22. His brother, Perry Joshua Barefield, 29 was also arrested. Both men were charged with murder. Imagine the thought of having two rapists and two murderers in the family. Ms. Rounsaville was shot while on her knees. During his trial Mr. John Barefiled said he was cruising with his brother and Ernest Lee Sonnier, 23 when they saw Cindy Rousaville walking. The abducted her at gunpoint. John Kennedy Barefield was sentenced to death. His mother was in the courtroom. Mr. Ernest Lee Sonnier was sentenced to life in prison after being found guilty of a December 24, 1985 rape and kidnapping of a 28 year old woman. He was exonerated in 2009. DNA also excluded him for the rape and murder of Cindy Rounsaville. Mr. Sonnier spent 23 years in prison as an innocent man another reason against the death penalty in this nation. He was found guilty by association. The police said the men trolled for victims they could rape and rob. Mr. J. K. Barefield was executed March 13, 1997. He lived on death row for 11 years. We do not know if Perry Barefield was convicted. We do know there was a Mr. Perry Barefield, 52, shot to death November 3, 2009. His accused assailant was a woman. Cindy R. Rounsaville was scheduled to graduate in May and to marry in July. These men help to destroy her life and accomplishments. Her name was called out during commencement and her parents accepted her bachelor's degree in architecture.

Claudia Benson, 21

Claudia Benson was pursuing a career in nursing. She was attending Henry Ford Community College in Dearborn, Michigan. She was robbed and shot to death outside a bar and grill at about 12:01am. Saturday, January 14, 2012. Benson later died from her injuries. Her family

said Claudia Benson had just finalized her college class schedule last week, so she went out to celebrate with friends. 35-year-old Jacob Wells was first-degree murder, felony murder, armed robbery, assault with intent to rob and felon in possession of a firearm. He was caught on camera. Jacob Wells was identified through a surveillance video from a nearby business. He could have snatched her purse but he did not have to shoot her. Mr. Wells is now in prison. He will never see a blade of grass again unless it is on television. This man deserves to be off the street because he is a fool. He had no idea how much money Ms. Benson had in her purse. He shot this woman to death not knowing how much money he would receive for his deed. He was arrested within 24 hours of the murder. This behavior is beyond stupid. Let his father please stand up.

Colleen Slemmer, 19

Colleen Slemmer lived in Orange Park, Florida. She was a job Corp student working in Tennessee. This adventured was supposed to change her life for the better. Her future and place in society was supposed to change. After a few years of training Colleen could look forward to a brighter future. Yet all Colleen met was violence. She was tortured and murdered in 1995 on the University of Tennessee Agricultural campus. Her body was found Friday, January 14, 1995. She was murdered the day before. The investigating officers described the crime scene as horrific. Colleen Slemmer and Christa Pike were romantically linked to Tadaryl Shipp 17. Christa Pike was angry and wanted revenge. So she enlisted the help of Shadolla Peterson and had Tadaryl Shipp lure Colleen Slemmer to a site where they stabbed and beat her to death. They carved a pentagram on her chest and did other things to her body. The prosecutor went to great lengths to show the jury what the trio had done to Colleen Slemmer. Colleen Slemmer skull was on display during the murder trial of Christa Pike. The skull was one of the pieces of evidence physically linking Colleen Slemmer to Christa Pike. A fragment of Colleen Slemmer's skull was found in Christa Pike's jacket. The fragment was taken so Colleen's soul could never leave her body. Thus she would never ascend to heaven. Satanists believe a body has to be whole for the soul to escape the body. The prosecutor sought the death penalty because of the viciousness of the murder. Murderer Status: Christa Gail Pik, 20, was tried and found guilty of first-degree murder in 1995. Two other teen-agers are accused in the murder. Christa Pike's attorneys asked for a new trial stating Christa Pike was unfairly tried in Knox County. A psychologist testified Christa Pike 20 was afraid Colleen Slemmer would take her boyfriend. Let's see what she is afraid of now that she is the author of this horrific murder. She was sentenced to death January 12, 1996. September 10, 1998 the Tennessee Supreme Court was asked to hear her appeal. The appeal was challenging the death penalty. Her attorneys were arguing that she did not get a fair try because of pretrial publicity and the town did not like Christa Pike. The defense had asked for a change of venue. Also the prosecutor did not show premeditation which is necessary for a first degree charge. It should be noted here that Christa Pike was heard the night before threatening to kill Christa Gail said after being kicked, beaten, stabbed, Colleen began to beg for her life. She wouldn't shut up. She kept talking and talking. She would start talking again, and I would say, "Shut up' I didn't want to hear her talking. This murder went well beyond jealousy. This murder was about power. Christa Gail was an insufficient person even in her own eyes. Colleen Slemmer had to die for Christa Gail to find peace from the comparison. Yes, Colleen Slemmer was a pretty young woman. Imagine how her mother felt. She let Colleen Slemmer go to Tennessee to better herself only to learn that her daughter had been murdered by monsters and part of her daughter's skull was being held for evidence and her murderess had a website and her memorabilia was being sold. Danielle Hagbery, 22

On January 10, 2010 Danielle Hagbery, 22, a student, was shot to death in Manhattan Beach, California after telling her boyfriend she wanted to break up with him. She attended the Cal State University Long Beach. Authorities said Michael Nowlin, 24, shot Ms. Hagbery then himself. L.A. County Sheriff Lt. Dan Rosenberg said that he hopes other young women take heed from the tragic circumstances that appear to have led to Danielle Hagbery's death. "Young ladies need to be vigilante. "If threatening comments, threats or statements are made, they need to be extremely careful."

Darlene Ann Webb, 20 (The assailant is still at large) Mary Michelle Sprague, 19 (mother)

Darlene Ann Webb was reported missing from Daytona Beach, Florida. Darlene Webb, 20, was a student at Daytona Beach Community College. She was last seen January 22, 1983 walking to her car. She met her friend at a local bar but her girlfriend decided to continue with a male she met leaving Darlene Webb to walk to her car alone. This was the last time she was seen. Her purse was found inside the vehicle along with her driver's license, glasses, and a few dollars. Mary Sprague lived in Daytona Beach, Volusia County, Florida. She worked as a dancer in one of the local bars. She was last seen September 11, 1979 after picking up her check and chatting with her employer. A cabdriver picked her up and had to elude a truck that seemed to be following her. Both women disappeared during the time William Bradford was visiting the area. He rode a motorcycle and visited local bars and used a camera to lure women.

Dawn M. McCreery 20

Wendy J. Offredo, 21

Dawn M. McCreey and Wendy J. Offredo were students at the University of Akron. They were raped and beaten to death September 1986 during the Labor Day week-end. . The crime was stupid and senseless. Two beautiful young women murdered because three young men refused to work for the money they wanted. The young men felt it was easier and faster to rob two defenseless women. Two teen-age boys intent on robbing someone decided to throw a huge piece of concrete (35 lbs.) onto a car from a freeway overpass. A friend of the boys testified in court that the girls were beaten to death because one of the women knew her attacker. Murderer Status: Richard Cooey II, 19, and Clint Dickens, 17, were arraigned on charges of murder. They were charged with 2 counts of aggravated robbery, 2 counts aggravated murder, 2 counts of kidnapping and 4 counts of rape. Richard Wade Cooey II pleaded innocent by reason of insanity. I did it but I was insane at the time. Richard Cooey elected for a panel of judges to hear his case. He was found guilty on all 13 counts November 1986. During the sentence hearing December 6, 1986 Judge James Winter, a Summit County Common Pleas judge, told Cooey "Your actions were brutal, savage and senseless. He promptly sentenced Richard Cooey II to death. He set the date for May 1, 1987. The judges deliberated 90 minutes before bringing back their verdict. The judge probably went in his chambers and drank a cup of coffee. Clint Dickens was tried as an adult. He pleaded innocent December 18, 1986 and asked for a trial by three judges rather than face a panel of 12 jurors. January 5, 1987 Clint Dickens pleaded no contest that automatically withdrew his innocent plea. He was sentenced January 7, 1987 to two consecutive life sentences for the murders and 35 to 90 years for other charges relating to the murders. He will not be eligible for parole until he has served 75 years in prison, the year 2062. Kenneth Horonetz, 18, was sentenced to 3 to 15 years for his role in the murder of the two college students. He was paroled a year later. Two women lay dead in 1986 and he is paroled July 1987. Richard Cooey was executed October 14, 2008. Dawn McCreery and Wendy Offredo were two sorority sisters who were leaving their jobs as waitresses driving home when they were assaulted.

Mrs. Dawn Marie Romano Garvin Lori E. Ward, 25 Patricia A. Hirt, 43

"The poor girl was working her way through school and putting herself through college. "Oken just checked into the motel and a couple hours later murdered her.....

This individual brutally murdered the three women. "I have no doubt that he would have murdered again if we hadn't caught him. "I've never in my law enforcement career seen a person who deserves the death penalty more than this individual. "I'm just glad they have the death penalty in Maryland."

Kittery Maine Police Chief Edward Strong

Dawn Garvin lived in Maryland in the White March apartment complex. She was a business student who recently married. Her father found her body November 1, 1987. She had been murdered. She was found clutching her teddy bear. She was shot twice in the head. Her assailant would be arrested in Maine for the murder of another woman before he would be arraigned for Mrs. Garvin's death. In fact the man who murdered Dawn Garvin would be charged with three capital offense. He would be accused of murdering his sister in law, Patricia A. Hirt and Lori E. Ward, a hotel desk clerk and a student. Patricia Hirt was raped, strangled then shot in her brother in law's home November 15, 1987 as she tried to return a camera she had borrow. Her brother in law either hated her or he sought revenge against his ex-wife. Patricia Hirt was his ex-wife's oldest sister. Her body was found in a drainage ditch. Lori Ward was murdered in the Coachman Motor Inn in Kittery, Maine March 11, 1987 shortly after renting a room to her assailant. Steven Oken, 25, was arrested in Maine November 17, 1987. He was described as a rich well educated white male who worked as a pharmacy clerk. After his arrested everything went downhill. He was convicted and sentenced to death January 18, 1991 for the murder of Dawn Garvin. He was sentenced to life in prison for the rape charge. April 23, 1991 he pled guilty to the murder of his sister in law. He was sentenced to life in prison without parole. Mr. Oken was convicted in Maine for the murder of college student, Lori Ward, and sentenced to life in prison without parole. Ms. Ward was working in the hotel to pay her tuition. You will later read she is not the only student murdered while working in a hotel to pay tuition. Steven Oken, 42, was executed June 17, 2004 for the murder of Dawn Garvin by lethal injection in the state of Maryland. He was the first murderer executed in Maryland in 2004 and the 4th murderer executed in Maryland since 1976 when the death penalty was reinstated in the United States. Kittery Maine Police Chief Edward Strong said, "I'm just glad they have the death penalty in Maryland." He was college educated.

Dawn M. Rossignol, 21

Dawn Rossignol was an excellent student who made the dean's list at Colby College. She was a biology major. Ms. Rossignol was a semifinalist for National Merit Scholar as a junior in high school and won academic medals, academic awards and academic letters. She was in the Foreign Language Club, the gifted-and-talented program, the school math team and National Honor Society. She worked in the college cafeteria. She was determined to graduate and be a success. September 18, 2003 Ms. Rossignol's body was found near the campus. She left her dorm at 7:20 am September 16, 2003. **Edward J. Hackett, 47**, a **parolee** from Utah was arrested 6 days later. He was living with his parents. Remember, there is an agreement between states to parole one another's felons? Mr. Hackett too was trolling for a victim. Mr. Hackett was found guilty in 2004 and sentenced to life in prison without parole. Maine is one of the states where a life sentenced is just that life. The police got the right man. He pleaded

guilty to kidnapping, murder robbery and aggravated assault. Mr. Edward Hackett was not just walking the streets at 7o'clock in the morning he knew there were a plethora of victims on the college campus. He knew where to go to find his victim. Dawn Rossignol was murdered six months after Mr. Hackett was release from the Utah prison. He was a rapist that the court refused to deal with. He had a history of kidnapping women so why did Utah parole him?

Dawn Rene Fehring, 27

Dawn Fehring was a Bible college student at Issaquah's Lutheran Bible Institute. She was also a former missionary. She had worked overseas but returned to Kirkland, Washington to complete other studies. Mother's Day 1995 she was found strangled to death in her condominium. Her neighbor Eric Hayden, 31, was charged with her murder after his bloody palm print was found on her bed sheet. It took the jury less than two hours to find him guilty of first-degree murder in 1996. Her family used the money donated to them to fund scholarships and missionary work. He strangled her to death. His excuse I was drunk.

Debbie Dorian, 22

Debbie Dorian was a senior student attending the Fresno State University. She was a few months away from graduation when she was raped and murdered in her apartment. When she was found she was bound and gagged. She died of asphyxiation. DNA was taken from the scene. There was no match to an assailant but the DNA match the evidence collected from eight rape cases in the area from July 1999 and August 2002. A \$57,000 reward is being offered for information leading to an arrest

Deborah Kraskey, 23

Deborah Kraskey lived in Huntington, Long Island New York. She attended Boston College in Massachusetts. She was murdered while on vacation in Trinidad Spain. March 26, 1973 her body was found in her room in the Trinidad Hilton. She was strangled to death. She had been gagged, stabbed then her body was placed in the closet

Deborah Lynn Wilson, 20

Deborah Lynn Wilson was a math major in her junior year attending Drexel University in Pittsburgh, Pennsylvania. Her body was found November 30, 1984 beaten and strangled in a basement of the computer lab. She was found without her shoes or socks. During the 1993 trial of her alleged assailant years later two security employees testified that the security on campus was a sham. Many of the guards slept on duty and or used drugs. They did not make security checks and they were able to bypass the security points because they had keys. One employee stated the security company would not provide flash lights for the guards. David Willim Dickson, 33, a Army recruiting sergeant, was arrested in 1993. He was later convicted and sentenced to life in prison.

Deborah Sheppard, 23

"I want to see a trial take place and I want to see a verdict come in and I want to see an execution take place. I'd like to see him on a gurney with a lethal injection in his arm. It won't bring my daughter back. Nothing can change that, but there are far too many people

spending their natural lives in prison enjoying themselves and spending taxpayers' money

for committing horrendous crimes." Bernie Sheppard, father

See Chapter Twelve, They Are Living Quietly Among Us – Deborah Sheppard's assailant was a fellow student. He murdered nine women two women in Illinois, one woman in Pennsylvania, one woman in Kentucky and five women in Missouri. He started raping women at the age of 18. He started killing women in 1977. Deborah Sheppard was murdered in 1982. He murderer did not come to trial until 2007.

Jessica Lee Cain, 17 Mrs. Tiffany Johnston, 19 Laura Kate Smithers, 12 Delli Cox, 20 (mother) 3 rape victims.

Delli Cox lived in Denton, Texas. She was a student attending the University of North Texas. She was reported missing July 15. 1997. Delli Cox's remains were found April 2016 by the Denton Police after William Lewis Reece, 56, confessed to her murder and led police to her burial site. Mr. Reece is in prison serving 60 years for kidnapping a Harris County woman in May 1997. He abducted her from the roadside after pretending to help her fix her flat tire. William Reece also helped the police find the remains of Jessica Cain, 17. She was reported missing August 17, 1997. He now stands charged with the first-degree murder and kidnapping of Tiffany Johnson. Tiffany Johnson was abducted from an Oklahoma car wash July 26, 1997. The charge in Oklahoma came after authority's link him to Ms. Johnson's murder through DNA in 2015. His indictment in the murder of Tiffany Johnson may be the reason why William Reece told authorities where to find the bodies of Delli Cox and Jessica Cain. He is the prime suspect in the rape and murder of Laura Smithers of Friendswood, Texas. Laura Smithers disappeared from her home in Galveston County Texas April 3, 1997. Her nude body was found 17 days later in retention in Pasadena in Harris County. Mr. Reece was working on a construction job near her home. William Reece was arrested October 1997 for kidnapping and assaulting Sandra Sapaugh May 16. 1997. He kidnapped Ms. Sapaugh by pulling a knife on her and forced her into his truck. Look at these dates. On April 3, 1997 Laura Smithers was murdered. On May 16, 1997 Sandra Spaugh was kidnapped. On July 15, 1997 Kelly Cox was murdered. On July 26, 1997 Tiffany Johnston was murdered. On August 17, 1997 Jessica Cain was murdered. Surely, if he had not been arrested in October of 1997 more women would have been murdered. Mrs. Johnston was a newlywed. She disappeared while getting her car washed just off Interstate 45. Her 1995 Dodge Neon was found at the carwash with the keys inside. Her body was found the next day. She was raped and strangled to death. Ms. Cain went missing on her way home from a theater cast party, where she celebrated playing Marilyn Monroe in a 50s revival play. Her beige 1992 Ford pickup was found on the side of Interstate 45 with her phone and wallet locked inside.

Denita Monique Smith, 25,

"Jermeir Stroud caused a perfect storm to happen and walked away from it,"
Superior Court Judge Ronald Stephens

Denita Monique Smith was a recent graduate of North Carolina Central University in Durham County North Carolina. She was a full-time Masters student at NC Central University. Everyone was excited looking forward to the future. She was shot to death January 4, 2009.

Smith, 25, was shot in the head at Campus Crossing Apartments in Durham and then fell down a stairwell to the sidewalk, where a maintenance man found her body. Her rival, Shannon Elizabeth Crawley, was arrested January 9, 2009. She was convicted and sentenced to life in prison without parole January 22, 2013. Shannon Crawley is a mother. Ms. Crawley and Ms. Smith were allegedly entangled in a love triangle with Greensboro police officer Jermeir Stroud, who also was Smith's fiancé. Ms. Crawley was his mistress. Authorities maintained that Shannon Crawley stalked Smith in a jealous rage because she had a former relationship with Smith's fiance, Greensboro police officer Jermeir Stroud. Officer Stroud admitted during the trial that he dated Shannon Crawley and Denita Smith at the same time.

Donna Denise Arrington, 24

Donna Denise Arrington, 24, was a college student majoring in education at the University of District of Columbia. She was driving through Maryland January 6, 1995 and needed directions. She stopped her car and asked James Darnell Syndor, 16, of Greenbelt, Maryland for directions. He was walking along the road. In that second she lost her life. He forced his way into the car abducted her from the roadway took her to an area raped her then set her on fire while she was alive. Her body was found by a man walking his dog. Her body was still smoldering. An autopsy showed that Arrington was first choked, then sexually assaulted, then set afire while she was unconscious. Her family learned of her death while watching the news. She was identified by her dental records and shoes. Jimmie Darnell Sydnor was arrested and charged with first-degree murder, robbery and rape. He was ordered held without bond. He folded and could not sustain his alleged innocence. April 24, 1996 James Sydnor pleaded guilty to firstdegree murder and rape charges in exchange for a prosecutor's recommendation of two consecutive life prison term. The prosecutor could not seek the death penalty. James Syndor was 16 when he raped and murdered Donna Arrington. We looked he is still in prison. He has been there for 17 years. Donna Arrington worked in a nail salon to pay her way through school. She was two classes away from graduation. This is the woman he killed.

Diane Dawn Vicari, 19

Diane Vicari did not get justice. She lived in Arizona and attended the Pima Community College. She was last seen October 22, 1992 at a disco. She was presumed raped assaulted and mutilated. Only her arms were found in a dumpster. Mr. Lemuel Prion, a sex offender, was tried, convicted and sentenced to death in 1992. In 2002 in a unanimous decision the Arizona's highest court voided the conviction of Lemuel Prion. The jurists said his trial was unfair. Actually the high court said the prosecution was wrong to have a single trial for Mr. Prion in the death of Diana Vicari and the kidnapping and assault of Tammy Godfrey. The court said the facts in the case were separate and "quite distinct" from each other. Chief Justice Charles Jones wrote the ruling. 1. He said that Pima County Superior Court Judge Bernardo Velasco was wrong in refusing to let Mr. Prion's attorney's present evidence that someone else had both the motive and opportunity to kill Miss Vicari. 2 Chief Justice Jones said "To be relevant, the evidence need only tend to create a reasonable doubt as to the defendant's quilt." Jones said the evidence outweighs the chance of confusion. The jury should have heard about the possibility of another assailant in the bar that night. 3. Judge Velasco should have granted the request by Prion's lawyers for separate trials on the Vicari murder and the charges of rape and kidnapping of Godfrey. "Any connection between the two crimes is attenuated at best. "The most that can be said is that each occurred in Tucson at the end of 1992, each involved a female victim, and a knife or knives were used by the perpetrator(s) at some point during the commission of the crimes." Justice Charles Jones said the cases were dissimilar: Ms. Vicari was a 19-year-old college student seen at a bar with Prion; Godfrey was a 35-year-old street

prostitute involved with drugs when she was detained by a man against her will and threatened with a knife before being ultimately released. Lemuel Prion was tried, convicted and sentenced to death for the murder of Diane Vicari with no direct evidence to his guilt. The entire case was circumstantial. How can you take a man's life on circumstantial evidence? There was no physical evidence tying him to the case. The prosecutor linked the death of Diane Vicari and the rape and assault of a lady of the night and tried Mr. Prion for all charges in one trial. The premise Mr. Lemuel Prion is a convicted sex offender. He assaulted and raped a woman. He discussed the rape and murder of a woman with a cell mate therefore he murdered Diane Vicari. Mr. Prion has been on death row since 1992. Mr. Prion's attorney sought, unsuccessfully, to present evidence that another man had been a co-worker of Ms. Vicari's and that he was disciplined for sexually harassing female co-workers on the job, he tried to conceal his discipline from police and he attempted to rape a co-worker at his apartment after work. The man also rented a new apartment on the day of Diane Vicari's disappearance - an apartment close to where her car was found. And he was working at the disco the night she disappeared. He denied this information when questioned by police. Remember what we said about men who sexually harass women at work. Their backgrounds should be scrupulously checked. Pizza parlors, in fact any fast food restaurant can be teeming with sex offenders because these are the jobs they seek; the anonymous fast food worker. We do not know the disposition of this case. What we do know is Diana Vicari did not get justice. The jury never heard evidence that another man had the motive and opportunity to kill. Has he been tried and convicted of any sexual offenses since the death of Diane Vicari? Has he continued to harass his female coworkers?

Diane Edwards 19 (See Marlys Wohlenhaus)

Diane Edwards lived in Minnesota. She was attending the University of Minnesota. She worked as a part-time waitress. We believe this is how she was targeted for murder because Marlys Wohlenhaus, a high school student, also worked as a waitress and we have cases of several other waitresses who were murdered by a customer. It is very easy for a woman working as a waitress to be stalked. Diane Edwards was to begin her sophomore year September 26, 1980 when she was abducted in St. Paul, Minnesota. She was raped and murdered in a car. Joseph Ture knew what time she got off from work. He knew her routine and abducted her as she was walking home. Murderer Status: Joseph Ture Jr. was charged in her murder in 1981. He was convicted and sentenced to prison. Years later Mr. Joseph Ture would be tried for the murder of Marlys Wohlenhaus and Diane Edward's father was called to testify regarding his daughter's murder. December 23, 1996 Mr. Ture was in the Stillwater Prison serving a life sentence for the murder of Diane Edwards when he was indicted for the premeditated first-degree murder and intentional second-degree murder of Marlys Wohlenhaus. Miss Wohlenhaus was murdered in her Afton, Minnesota. Mr. Ture was subsequently found quilty of Miss Wohlenhaus' murder. During the trial Mr. Ture's defense attorney said Mr. Ture was at work when this murder was committed and also Diane Edwards was murdered in a car and Marlys Wohlenhaus was murdered in her home May 8, 1979. While still in prison, Mr. Ture was indicted for four counts of first-degree murder for a woman and her three children who were murdered in their home. This disputed the defense claim that Mr. Ture had only one modus operandi. February 7, 2000 Mr. Ture was sentenced to four consecutive life sentences for the murder of Alice Huling and her children, Susan, Patti and Wayne in 1978. Mr. Ture committed these murders when he was young. He shall die in prison an old man. Please note the respect the Minnesota prosecutors showed the victims and the families of Miss Wohlenhaus and Mrs. Huling by trying their cases even though the defendant was in prison serving a life sentence for the 1980 murder of Diane Edwards. The prosecutors should be commended for understanding

the need for families to feel that justice was done for their love ones. Also note Mr. Ture was serving time for the murder of Ms. Edwards but he had murdered five more people that the police did not know about at the time of his original arrest. This situation substantiates the necessity of conducting DNA tests on men who are incarcerated. The problem understanding this case is the Huling Family was murdered in 1978 but their murder case was not adjudicated until 2000; Marlys Wohlenhaus was murdered in 1979 but her murder case did not go to trial until 1996; Diane Edwards was the last known victim in 1980 but her case was tried first.

Diane Wilder, 27

Karen Mandic, 22

Karen Mandrick and Diane Wilder lived in Bellingham, Washington. They were attending the Western Washington University. January 11, 1979 the young women befriended by a security guard named Kenneth Bianchi. The women were supposed to house sit at a home in the area. They were reported missing the next day by a friend. Forensic evidence was taken from the car and from a home that Kenneth Alessio Bianchi had access to that linked him to the murders. Both women were strangled. His arrest led to the discovery that he and his cousin, Angelo Buono had committed murder in California. The two men murdered ten women in California. Murderer Status: In Washington Kenneth Bianchi was charged with two counts of murder. He confessed to the murders and pled guilty to two counts of first-degree murder. He escaped the death penalty by testifying against his cousin. He did confess to murdering five women in California. He is now serving a life sentence without parole in the Walla Walla state prison. The Washington State Parole Board assigned him a term of one hundred and sixteen and a half years in prison for the murders of two young women in Bellingham. Mr. Bianchi was also sentenced in California to five life terms for the murder of five women.

Diona McDonald, 19
Timesha Carswell, 21

Diona McDonald and Timesha Carwell were to music major students attending Bethune-Cookman University in Daytona Beach, Florida. The two students were shot to death September 18, 2015 over an agreement with one of their housemates over his paying his share of the rent. Four people were renting the apartment three were students the other was 27-year-old York Bodden. Mr. Bodden was not a student he was dating Ms. Carswell. He was several months behind in the rent. The other three students wanted him to leave. He refused. An argument ensued. Mr. Bodden left the apartment and got a gun. He returned to the apartment argued some more. Fought with a male student then shot at the male student and killed Diona McDonald and Timesha Carswell. Mr. Bodden was arrested a few days later. His history includes kidnapping, robbery, and drugs. Mr. York Zed Bodden must have known Florida is a death penalty state because he committed suicide by hanging September 19, 2015 in his cell shortly after his arrest.

Dominique Hurd, 19 Peter Robertson, 19 Cecil Boren, 57 Jerrell Jenkins

Dominique Hurd lived in Texas. She moved to Arkansas to attend the University of Arkansas at Pine Bluff. She became a cheerleader. December 18, 1998 Dominique Hurd and another UAPB student, Peter Robertson, were kidnapped from the parking lot of a restaurant on Olive Street and then driven to Harden-Reed Road, where both were robbed and then shot repeatedly. Robertson recovered from his injuries Dominique did not. Mr. Robertson testified against Mr.

Williams. Kenneth Williams was subsequently convicted and sentenced to life in prison without parole. While in prison he escaped and murdered Cecil Boren, 57, October 3, 1999. He was again convicted this time he was sentenced to death. Kenneth Williams, 26, was later convicted for capital murder, aggravated robbery and theft of property in connection with the death of Jerrell Jenkins on December 14, 1998.

Dominique T. Frazier, 18

Dominique Frazier was a student at Bowie State University in Maryland. She was murdered in her dorm room a September 15, 2011 during an argument. Her roommate, Alexis D. Simpson, stabbed her to death then pleaded self-defense in court. She was acquitted. She killed over a loud Ipod and an insult. The defense said she killed because she was afraid for her life. The two roommates argued often and traded insults. If you kill once in anger you will kill again in anger. We shall see what university she attends now. It is evident that Dominique T. Frazier thought she was just as pretty as Miss Simpson and she did not have to follow her lead. This was a cat fight that turned deadly. Some said the verdict was the benefit of the doubt.

Donna Fink, 22 John J. Bowes II. Marlene Mahnke 21 John R. Bazemore,

John Bowes was killed in Fort Lauderdale, Broward County, Florida, on May 5, 1970 for \$110.00. Donna Fink and Marlene Mahnke were two young women attending Florida Atlantic University in Boca Raton, Florida. Their bodies were found in a wooded area May 14, 1970 outside of the campus. Both women were shot in the head. They were killed May 5, 1970 for their car. Ben Chaney, 17, and Martin Rutrell, 15, were indicted on two counts of first-degree murder. They were driving the victim's car. The men were convicted in 1971. John R. Bazemore, employee at a Simons Fireworks stand, was killed May 15, 1970 in in Jasper County, South Carolina.

Donna DeRier, 19

Donna DeRier was attending Montclair State College. August 1965 she was staying with her parents at their summer place and working part time at the Grand Union to help pay her college expenses. Donna De Rier stopped at a traffic light in Manasquan when William Doss forced his way into her car. He forced her to drive to a state park in New Jersey where he raped her and bludgeoned her to death with a 2 by 4. William Doss was convicted of capital murder in 1966 and sentenced to death. The death sentence was overturned in 1972 and he was given "life in prison. In 1981, he was eligible for parole. 2,100 people wrote the parole board asking that he not be paroled. Donna DeRier's brother, Ronald DeRier, fought William Doss' parole until Mr. Ross died in prison in 1992.

Donna Jou, 19

Donna Jou lived in Orange County California. She was a San Diego State University freshman with a bright future ahead of her. She advertised her math tutoring service on Craiglist and met a sex offender. She did not know John Burgess was a sex offender. Donna Jou was last seen alive by her family in June 2007 as she rode away on the back of Burgess's motorcycle. John Steven Burgess, 36, a convicted sex offender charged with involuntary manslaughter. He admitted to drugging (cocaine and heroin) and killing Donna Jou, then dumping her body into the Pacific Ocean. After his conviction in 2009 he spent only two of a five-year prison sentence in the murder of Donna Jou. Burgess was scheduled to be released from prison

March 15, 2011. Since there was no body and Mr. Burgess managed to post a \$250,000 bond when he was not employed and had no savings and someone was sending him \$200.00 a month while he was in prison it was proposed that he kidnapped Donna Jou as a human trafficker.

Donna Lynn Allen, 1983

Donna Allen was a student attending the University of Georgia. She was stabbed to death in a parking lot December 22, 1983 after leaving work. Warren Reid Hall, 25, was convicted and sentenced to life in prison. This is some of what Mr. Hall told a graduate student at the UGA Psychological Clinic. "I think a lot about rape. I think a lot about killing somebody. "These feelings of doing this [are] so strong I wonder sometimes if I wouldn't actually do them, you know, if the situation was ever right." "Last week when I came up here I brought a knife with me, and I had it in the sleeve of my jacket. It was a big knife, a butcher knife. And . . . I was thinking about finding somebody and raping and killing them." He was asked, "If you feel like killing somebody, if you feel like raping somebody, what do you do then?" "I usually look for ways that I can do it without getting caught," Hall answered. "I think about them and try to figure out the best way it would be to do it. "The women attending were not notified there was a person with homicidal thoughts on the campus. Ms. Allen was stabbed to death a few months later.

Dorothy Anderson, 24 (Her assailant is still at large)

Dorothy Anderson was working as a nurse aide in Long Island, New York. She was also attending the Manhattan Community college trying to change her life. Her body was found April 7, 1973 in the Mill River. Two women were found strangled to death in the same area in May and July.

Dzung Ngoc Tu, 25 see Chapter 2 page 80

Mrs. Elaine J. Graham, 33 (See C. Lutz and R. Johnson) (Her assailant is still at large)

Mrs. Graham's lived in Chardon, Ohio. She had taken a leave of absence from her job to attend Kent State University. She was working on obtaining a teaching degree. Her body was found burning in her car November 14, 1990 in Geauga County Ohio. Authorities believe she and her alleged attacker attended the same university. Murderer Status: Daniel R. Wilson is suspected in her death. He is also a suspect in the March 30 killing of Rachael M. Johnson, 23, of Tallmadge. He was in the Lorain County Jail in lieu of a \$200,000 bond in connection with the May 4 killing in Elyria of 24-year-old Carol L. Lutz of Amherst in Lorain County. At the age of 14 Mr. Wilson was convicted of murdering an 81-year old man in Elyria, Ohio. He broke in the man's home. Authorities from the Portage County sheriff's office are investigating Wilson as a suspect in the April 1990 shooting deaths of Cora and Bearnhardt Hartig, both 81. We did not find a conviction regarding the murder of Elaine J. Graham or Rachel Johnson.

Elisa Costilla, 32

Elisa Costilla was a graduate student of Texas A&I living in Austin, Texas. She was pursuing a doctorate degree in special education at the University of Texas. She was murdered June 25, 1997. Her body was dismembered. After the murder her alleged assailant, Luis Salinas, 30, drove around Austin, Texas in Elisa Costilla's car, once caught he showed the police where various parts of her body were located. Murderer Status: Luis Salinas, 30, was charged with murder. Police believe he was an old boyfriend if he murdered Elisa Costilla he may have an

envious old boyfriend. He admitted the murder. August 24, 1997 Mr. Salinas was found hanging in his cell. Her mother collected funds to establish a scholarship fund for graduate students in the name of Elisa Costilla. A man who is rejected is dangerous.

Elisa Davis, 19

On October 8, 2009 Elisa Davis, 19, a Cal State East Bay student, of Oakland, California was shot to death in a car. Eric Hicks Jr., 23, also a student, committed suicide after the shooting. The two had only dated a month.

Elisabeth Killam, 23 pregnant

On September 23, 2009 Elisabeth Killam, 23, of Tallahassee, Florida was strangled to death. She was pregnant. Terrell Lee Robinson, 36, was tried and convicted of first degree murder. He was sentenced to life without parole. He said he killed Ms. Killam because he was jealous of a relationship she had with another man. Elisabeth Killam was a Florida State University junior enrolled in the College of Visual Arts, Theatre and Dance.

Elizabeth Marriott, 19

Elizabeth Marriott was a 19 year old college student attending the University of New Hampshire. She was a marine biology major. Marriott was helping to put herself through college by working at Target. She lived with an aunt in Chester and commuted to the Durham campus. She disappeared early October 9, 2012. Police believe she has been murdered and were searching for her body. Seth Mazzaglia, 29, of Dover, a marital art instructor, was charged with seconddegree murder. He was convicted of first degree murder and sentenced June 24, 2014 to life in prison without parole. When he was arrested his friends were shocked. His friend had to be flabbergasted when they heard the testimony of his ex-girlfriend. She told the court that Seth Mazzaglia was angry that Elizabeth Marriott snubbed his sexual advances so he attacked Ms. Marriott in his apartment October 2012. He choked Ms. Marriott with a rope then raped her. How is that for knowing people? The ex-girlfriend told the court that she helped her exboyfriend throw Elizabeth Marriott's body in the river. Mr. Mazzaglia graduated from the University of New Hampshire in 2006 with a degree in theater. Seth Mazzaglia and Elizabeth Marriott met last summer when both were working at a Target store in Greenland, New Hampshire. Seth Mazzaglia was sentenced to life in prison without the possibility of parole. He told investigators Marriott died during consensual rough sex. Imagine Ms. Marriott was supposed to have had consensual sex with him in his apartment while is ex-girlfriend was present. He had to account for his dumping Ms. Marriott's body in the river. He had to come up with a plausible explanation to his ex-girlfriend's statement in court. If you are not a good liar one should stay away from bad deeds. Please read this article, Man convicted in rape, murder of college student, By LYNNE TUOHY, Associated Press, Friday, June 27, 2014, (Published in print: Saturday, June 28, 2014) A 20 year old woman was present when Elizabeth Marriott was raped and murdered. She told investigators she thought Seth Mazzaglia and her still had a future together after the rape and murder so she initially told a different story at first of what happened to protect Seth Mazzaglia. This is why men do not respect women and consider women weak minded.

Elizabeth Michelle Hafter, 22

Elizabeth Hafter was a graduate student in the Curry School of Education. She had finished her first degree at the University of Virginia and was looking forward to working on her masters.

She had made it further than most people. She had decided on what she wanted to do and she had succeeded. In October 2006 she told her family she was going to go for a walking in the nearby wooded area. October 3, 2006 her body was found on the Blue Ridge Parkway. She was a victim of a carjacker. She was shot in the head. Mr. William Ashby wanted the use of her car. Killing Elizabeth Hafter was no problem because he shot a convenience clerk September 24, in Effington County and was apparently on a shooting spree in Virginia, South Carolina, Tennessee and Florida. According to later reports he was wanted in four states. He was later surrounded by police in Florida where he committed suicide in Elizabeth Haftner's car. People had nothing but good things to say about Ms. Hafter. She was kind, helpful and loved helping people. This is the woman Mr. Ashby killed.

Emily Eagan, 19

Emily Howell, 20

Emily Eagan, 19, and Emily Howell, 20, were students attending Atioch College in Ohio. They left Ohio March 2000 to become part of an international student exchange programs in Puerto Viejo, Costa Rico. March 2000 both women were abducted and killed while walking home. Their bodies were dumped in the weeds along the highway heading north to Cahuita. Their bodies were riddled with bullets. They were killed 8 days after arriving in Costa Rico. Two men were arrested for the crime: a 16-year-old who was convicted in August 2000 and given the maximum sentence of about 15 years in prison, and an accomplice who awaits trial. A third alleged gunman has reportedly escaped to Nicaragua. Authorities contend the killers wanted the girls' car. A year later, May 13, 2001 Shannon Martin would be stabbed to death as she walked home from a nightclub in the southern Costa Rican town

Emily Rachel Silverstein, 19

Emily Silverstein was a 19 year old student attending Gettysburg College in Pennsylvania majoring in Anthropology. She was on the Dean's list. April 9, 2009 she was stabbed to death inside her ex-boyfriend's apartment. The medical examiner said Emily Silverstein died of multiple stab wounds and strangulation. September 2014 after a plea deal Mr. Kevin Schaeffer was sentenced to 26 to 53 years in prison. He was convicted of third-degree murder. He escaped from being sentenced to life in prison if convicted of first degree murder, which he should have been.

Emily Sander, 18

Emily Sanders lived in Kansas. She was attending the Butler Community College in El Dorado. She went to a local bar to recreate there she met Mr. Israel Mireles. What she did not know is Mr. Mireles was a violent man that he recently beat his pregnant girlfriend knocking out several of her teeth. Emily Sanders was last seen alive leaving the bar with Israel Mireles. Her body was found November 28, 2007. Murderer Status: Mr. Israel Mireles, 24, was arrested in Mexico and extradited to the United States. Mexico and Canada are good hiding places for men who murder in the United States. He told the student story that someone else raped sodomized and killed Emily Sanders. He just ran because he was afraid he would be blamed for the murder. The jury did not believe him and Mr. Mireles was convicted of all charges. Judge David Ricke did not believe him either so he sentenced Mr. Mireles to 203 years for rape and life without parole for the conviction of capital murder. You should see the before and after pictures of Mr. Mireles. It demonstrates how attorneys try to portray their clients before the jury. Imagine Mr. Israel Mireles was in the bar picking up women and his girlfriend was home pregnant. Years from now what explanation will be given to the child.

Erika Megan Sharpton, 24 (Her assailant is still at large)

Erika Sharpton lived in Tullahoma, Tennessee. She was a nursing student. Her body was found along the side of a road July 2, 2012. She died of blunt force trauma to the head. Her body was set afire. Her death was ruled a homicide. Donnie Frank Jones, 37, was arrested as a felon in possession of a firearm. He is also a suspect in the rape and murder of Erika Sharpton. There was a forensic matched found at the scene of the murder. As of September 11, 2012 her case remains unsolved.

Erin C. Nieswand

Yong Hee Suh (Young)

Erin C. Nieswand and Yong Hee Suh were students attending Cornell University in New York. They were murdered in their dormitory December 18, 1983. Young Hee Suh had refused the advances of a young man and he retaliated by holding several students hostage then murdering the above two young women. Murderer Status: Su Yong Kim was charged with two counts of murder and holding four students hostages. He was sentenced to 25 years to life in prison. The judge recommended Mr. Kim be deported to South Korea after he finished serving his sentence.

Erinn Abramson, 18

Erinn Abramson lived in Florida. She was a college freshman. After her parent's home was robbed April 1984 Erinn Abramson was abducted in her car. She was stabbed to death and her body was left in a vacant lot. The kidnapping and murder was committed by Mr. Russell Jason Sandborn, 28. He met her at a drug rehab center. The night Erinn Abramson was murdered Mr. Sanborn tried to visit her at her parent's home. This was another stupid murder. Mr. Sandborn probably thought it was his lucky day to meet a rich kid who drove a Mercedes. He was on probation. March 15, 1985 he was sentenced to life plus 134 years in prison. The judge structured the sentencing so Mr. Sandborn would never be released from prison.

Eve Marie Carson, 22

her

Posthumously Carson was given the prestigious Chancellor's Award for most outstanding woman in the senior class and two merit scholarships were established in her name after

death. 1700 people contributed to the first of those scholarship funds, totaling \$380,000. Other memorials have been devoted to her memory in the town of Chapel Hill.

The majority of the students attending the University of North Carolina- Chapel Hill knew Eve Carson. She was the student body president. She was a senior and a Morehead-Cain scholar. She was a member of Phi Beta Kappa and planned to go to medical school. Her friends said she was committed others. The life Eve Carson was creating for her self ended March 6, 2008. Ms. Carson was shot to death around 4:30 am. Why was she shot to death because someone wanted her car and her money? They forced her from her home took her to an ATM machine had her withdraw \$1,400 then shot her to death. In Michigan you cannot withdraw more than \$200.00 from a machine in a given 24 hours. Murderer Status: two men, Lawrence Alvin Lovette, 17, and Demario James Atwater, 21, in violation of their parole, were charged with kidnapping, robber and murder. North Carolina is a death penalty state. Both men avoided the death penalty by pleading guilty. The carjacking charge brought the men under federal jurisdiction.

Ms. Carson traveled, worked and studied in Cuba, Egypt and Ecuador. She volunteered as a physician's assistant to a traveling doctor in a rural area and worked on a coffee farm. She had taught computer skills to indigenous peoples in the Amazon rain forest and for a U.S. Naval Medical Research Unit in Cairo. She was building quite a life and two men who contributed nothing to this world will not sit in prison for the rest of their lives to pay for their actions of robbing the world of Eve Marie Carson's talent. There are some occasions when you would like to ask a person "Are you stupid or what. What is it about life that you do not get? In kindergarten children are taught keep their hands to themselves and leave another person's possessions alone. Clearly Mr. Lovette and Mr. Atwater did not understand that the mere thought that they were smart enough to pull off a robbery like this made them stupid. One has to understand those occasions when one's thinking can be stupid. This was such an occasion. These two men should have walked away from one another. Clearly neither was smarter than the other.

Evelyn Joy Ludlum, 25

Evelyn Joy Ludlum was attending the Macon Junior College in Georgia. She was working as a cocktail waitress to pay her way through school. There was nothing spectacular about Evelyn Ludlum. She had a boyfriend she was happy with her life and probably had dreams of one day walking across a state having everyone congratulate her upon graduation. This did not happen. What happened is the night of November 1981 she was abducted her from the parking lot to an isolated location where he raped and strangled her. Ellis Wayne Felker, a parolee, was convicted for the 1981 aggravated sodomy of Evelyn Ludlum. He was executed November 15, 1996. He was 48 years old. His claim of innocence has overshadowed her death. Many were concerned with the way evidence was handled and the conduct of the prosecuting attorney. He was a customer where she worked as a cocktail waitress. Evelyn Joy Ludlam worked as a waitress in a bar at a Holiday Inn in Warner Robins, Georgia. She met Ellis Wayne Felker and during their conversation she told him she was looking for a second job to help pay her tuition. He offered her a job in leather shop he operated. Evelyn Joy Ludlam went to talk to Mr. Felker about the job November 23, 1981. Two weeks after Ms. Ludlam went to meet Felker to talk about the job her body was found in a creek in Twiggs County. The cause of death was asphyxiation.

Faith Danielle Hedgepeth, 19 (Her assailant is still at large)

Faith Hedgepeth was a Native American. She was a member of the Haliwa-Saponi tribe of Hollister. She moved to Chapel Hill North Carolina to attend the University of North Carolina. Faith Hedgepeth was a biology major who won a Gates Millennium scholarship to study at UNC. Miss Hedgepeth was found dead inside her Chapel Hill apartment in early September 2012. There are no suspects.

Faith Worthey Guilliory, 45 (mother of 3)

On September 12, 2009 Faith Worthey Guillory, 45, graduated from the University of Phoenix. September 14, 2009 Faith Guillory, a mother of 3, was found shot to death in front of an apartment complex in LaMarque, Texas. Moises Perez Alvarez, 51, the ex-boyfriend, was the prime suspect. He had recently been released from jail. The police believe he has fled to Mexico. Family members said he kept threatening her.

Gina Gay Tenney, 19

In 1985 Gina Tenney was attending the Youngtown State University. She was living in an apartment off campus. What she did not know is she was living in the same building as a sex offender by the name of Bennie Adams. He was living with his girlfriend in the apartment below hers. This was his point of contact with the victim. He could watch her at his leisure and decide when the best time to strike. December 30, 1985 the body of Gina Gay Tenney, 19, was found in the Mahoning River in Youngstown, Ohio. She had been raped and strangled to death. Authorities believed Mr. Adams was involved in her murder but did not have the evidence. He was in possession of her ATM card. Her keys were in his trash. Bennie Adams was sentenced to death for the 1985 kidnapping, rape and strangulation death of YSU Co-ed Gina Tenney. His death sentence was upheld in 2011. He served 18 years in prison for the rape, kidnapping and murder of a school principal in 1985. Ohio released him from prison in 2004. In January 1986, a month after Ms. Tenney's murder, Bennie Adams was indicted in the kidnapping, rape and robbery of a Boardman woman and found guilty at trial. The crimes occurred in the summer of 1985. This is a situation where the use of computers would have been useful. A database could be created with certain parameters asking if certain men arrested ever lived next door to a murder victim. We need to invest more money in law enforcement.

Gina Marie Langevin 26

Gina Marie Langevin was a student at a college in Florida. She and her roommate, Jena Hull, 24, were stabbed in their apartment September 18, 1993 in Gainesville, Florida. Gina Marie Langevin died her roommate survived. Murderer Status: Richard Meissner, 27, was charged with murder. He was found guilty April 13, 1995. Gina Langevin was a University of Florida graduate student. She was determined to be an architect.

Grace Rebecca Mann, 20

Grace Mann was a student attending University of Mary Washington in Fredericksburg, Virginia. Ms. Mann had several housemates. It is common practice at universities for 8 or 8 students to share a house to reduce expenses. April 17, 2015 some of her housemates found the body of Grace Mann's. Steven Briel was in the home. She was unconscious in her bedroom. She was restrained and had a plastic bag stuffed into her throat when she was found. Mr. Briel fled. Ms. Mann was taken to the hospital but she did not survive. The cause of death was listed as strangulation. After a short manhunt Steven Vander Briel, 30, was arrested and charged with first degree murder and abduction. No bond. There was no known personal relationship between the two students.

Hannah Elizabeth Graham, 18,

Hannah Graham was a sophomore student attending the University of Virginia in Charlottesville. Ms. Graham was seen at a pizza shop September 13, 2014. She and her friends were attending parties near campus. She was last seen on surveillance video about 1am Saturday walking on the city's pedestrian mall, apparently lost. Jesse Leroy Matthew Jr., 32, charged with abduction with intent to defile September 15, 2014 in the disappearance of Hannah Graham. He was arrested in Galveston, Texas. October 17, 2014 Hannah Graham's remains were found in Albernarle County.

Hannah Wilson, 22

"I can't even stop crying. I keep expecting her to text me back or to wake up and

this all be a horrible nightmare." Friend.

"She was so good at cheerleading.. "She was so good. Everyone wanted to be Hannah Wilson. Everyone wanted to have her tumbling, everyone wanted to have her smile, her laugh... She just-- She had it going on." Abby King, a friend

Hannah Wilson was a University of Indiana student in Bloomington. She was a senior soon to graduate with a degree in psychology. She was considered a gifted student. Her body was found April 24, 2015 shortly after she was reported missing. Daniel E. Messel, 49, was arrested approximately 24 hours later. Hannah Wilson was murdered around 1 am. Her body was found seven hours later. She was beaten about the head. She died of blunt force trauma. There was no evidence that she was tied up or sexually assaulted. Friends believe she was walking by herself. A charge of kidnapping is being considered which will subject Mr. Messel to the death penalty. Police found blood and hair inside Messel's car and, when he was arrested, he was carrying a trash bag full of clothes.

Haruka Weiser, 18

Haruka Weiser was a first-year University of Texas theatre and dance student from Portland, Oregon. Her body was discovered in a creek near the alumni center and football stadium of the University's Austin campus. She was raped and strangled to death. She was seen leaving the UT's drama building around 9:30 p.m. This was the first murder on campus since 1969. Meechaiel Khalil Criner, 17, A homeless teenager was arrested and charged with murder. His bond was set at a million dollars.

Heather Elvis, 20.

Heather Elvis lived in Horry County South Carolina. She was cosmetology student attending a school in the area. She disappeared after a date December 18, 2013. She was reported missing the same day by her father. Her car was later found abandoned. Authorizes believe Ms. Elvis was murdered at Peachtree Boat Landing in Socastee, South Carolina the same days she was reported missing. February 25, 2014 Sidney Moorer, 38, and Tammy Moorer, 41, were charged in the murder of Heather Elvis. Charges were later amended to include kidnapping. The police believe Sidney Moorer lured Heather out of the safety of her apartment around 3 am. where she was to meet with him. At their meeting she was confronted by Tammy Moorer where Heather Elvis was murdered. This was a sexual homicide. Sidney Moorer refused to take a polygraph. A \$30,000 reward was offered. The Moorer were allowed \$100,000 bond each and required to wear a tether. March 10, 2016 murder charges were dismissed against the Moorers An obstruction of justice charge was also dismissed for Tammy Moorer and two charges of indecent exposure have also been dismissed against both. The kidnapping charge is still in place for Tammy and Sidney Moorer,

Heather Marie Haupin, 19 (mother)

Heather Haupin lived in Florida. She decided to change her life now that she was a mother. She attended the University of Florida in Tampa. She started school after breaking up with her boyfriend, Peter Howarth, 22. February 17, 1994 she was shot to death on campus. Her exboyfriend, Peter Howarth, 22, also shot himself. He lay in a coma at a local hospital. Later he was convicted of first-degree murder April 24, 1996 and sentenced to life in prison without parole. He is still in prison.

Heidi Lynn Childs, 18

David Metzler, 19

On August 26, 2009 two Virginia Tech students, David Metzler, 19, and Heidi Childs, 18, were shot to death in the Jefferson National Forest. They went to the camp ground to have fun and play their guitar. Both were sophomores. Ms. Childs' father is a Virginia state trooper. Mr. Metzler was studying engineering and Ms. Childs was studying biochemistry. The cases remain unsolved. Murders like this have occurred in California and Washington at state parks.

Heidi Goldberg 19

Heidi Goldberg was a student of the State University College in Old Westbury, New York. She was murdered on campus June 10, 1984. Murderer Status: Warren Bass was charged with rape and murder. He was a previous employee of the university.

Helene Pruszynski, 21 (Her assailant is still at large)

Helene Ptuszynski was a visitor to Denver, Colorado in 1980. She was a student attending Wheaton College in Massachusetts but she was living with an aunt while working as an intern at KHOW radio. She was last seen alive the evening of January 16, 1980. Her body as found a short time later. She was bound raped and stabbed 18 times in the back. Murderer Status: unknown

Hillary Johnson, 24

Hillary Johnson lived in Chicago, Illinois. Hillary Johnson moved south to work on her graduate degree. She was in Tennessee attending the University of Memphis as a graduate student. Ms. Johnson was reported missing November 20, 1999. She failed to attend Thanksgiving with her family. Her car was found November 30, 1999 in woods in Tippah County, Mississippi, about 50 miles east of Memphis. The primary suspect in her disappearance was Leonard Jasper Young, 54. Mr. Young is a known sexual predator and a felon. He was a parolee. Leonard J. Young, 54, the man who stole her car, lived in a cabin nearby. He told the police he took Hillary Johnson's car but let her off on the highway. Hilary Johnson's body was found December 5, 1999 in a field. Police believe Hillary Johnson was abducted November 20, 1999, near her apartment at the University of Memphis. She was accosted as she was exiting her car late in the evening. The state Supreme Court upheld Mr. Young's death sentenced June 2006. Mr. Leonard Young had not been out of prison a year before he committed this murder. He stabbed Hillary Johnson once in the back with such force that the knife blade remained embedded in her body, the handle detached

Holly Bobb, 20

Holly Bobb was a Darden, Tennessee nursing student. She has been missing since April 13, 2011. March 6, 2014 we learned that Mr. Zachary Rye Adams, 29, was charged with the kidnapping and murder of Holly Bobb. We rarely if ever comment on the appearance of alleged assailants but Mr. Adams does not have a good appearance. We do not believe the jury will like him. The jury is going to see a photo of a beautiful girl with a brilliant smile then they will look at him. The defense will not be able to dress him up or make him look normal with a new suit. He is accused of destroying a family's future. District Attorney General Hansel McAdams said he believes Ms. Bobb was taken forcefully from her home. This makes the act kidnapping. He will seek the death penalty if Mr. Adams is convicted. If the rape and murder occurred as discussed on the internet, the death of Holly Bobb is definitely a death penalty case. Zach

Adams, 29, was charged with first degree murder and especially aggravated kidnapping. His brother, John Dylan Adams, told police that he witnessed Holly Bobo alive with his brother at the home they share following her abduction. His brother, Dylan Adams, was charged with rape based on a statement he made to police, where he allegedly admitted to raping Holly. Zach Adam's friend, Jason Wayne Autry, 39, was a charged with especially aggravated kidnapping and first-degree murder. Police believed that Zach's friend, Shayne Kyle Austin, helped to dispose of the body.

During a preliminary hearing Sandra King testified that she saw missing student Holly Bobo tied up and crying in cell phone footage shown to her by Jeffrey Pearcy. Image the depravity. Her remains were confirmed September 2014.

Imette St. Guillen, 25

Imette St. Guillen was a John Jay College of Criminal Justice student. She was studying criminal justice and due to graduate June 2006. She was raped and murdered earlier on February 25, 2006, allegedly by one of the bouncers at The Falls Bar. The body of Imette St. Guillen was found after an anonymous phone call was made from the Lindenwood Diner to New York Police Department. Darryl Littlejohn, a parolee, in violation of his parole was last seen with Ms. St. Guillen. His DNA was found on the ties that were used to bin St. Guillen hands. He was charged with first-degree murder, kidnapping, and unlawful imprisonment. He was convicted and sentenced to life in prison without parole.

Iofemi Hightower, 20 Terrance Aerial, 18, Dashon Harvey, 20 and Natasha Aerial, 19, survived

"She was one of the most beautiful ladies you'd ever want to meet. Very smart, very intelligent. She wanted to be something in life." John McClain, lofemi's great uncle

"I don't ever want the world to forget my daughter as well as her friends they were good kids they had ambitions, they had goals." Shalga Hightower, mother

"We are deeply saddened over the violent shooting incident that took the lives of two of our students and left one seriously injured. "While the murder of the two students is a terribly loss in human terms, the facts that they were a part of the DSU family and were striving to earn a degree, create a bright future for themselves and become a solid contributors to society, makes this violent act especially tragic and senseless. University President Allen Sessoms

The death of Ms. Hightower and her friends in New Jersey made absolutely no sense. The murders were an insane act committed by a group of men who wanted to become part of a gang. July 2007 four friends, all college students, were socializing near an elementary school

The four had been listening to music in a parking lot behind Mount Vernon School. All were from Newark, New Jersey and planned to attend <u>Delaware State University</u>. None of the victims had criminal records or were tied to any gangs. A group of five men approached there group. The men shot Natasha Aerial, then forced Terrance Aerial, Dashon Harvey and Iofemi Hightower down an alley, lined them up against a wall, made them kneel and shot each in the head. The reason why all of the events are known is because Natasha Aerial survived. She testified in 2011 during the trial of Alexander Alfaro, 27. Alfaro, his half-brother <u>Rodolfo Godinez</u>, and four others targeted the group to make their mark with the gang MS-13. Mr. Godinez was convicted

in May 2010 and sentenced to 245 years in prison. Prosecutors said Mr. Godinez orchestrated the attack as part of a gang initiation. He was a recruiter. The four college students were friend since elementary school. Ms. Hightower and the Aeriels had played together in the West Side High School marching band. Terrence Aeriel took Hightower to prom in 2006, chauffeured by his sister. The three met Harvey at Delaware State. Dashon Harvey planned to graduate from Delaware State with a degree in psychology in 2009. Terrence Aeriel was studying business management in college. He played the baritone saxophone and attended Delaware State's band camp last summer. He also worked with kids at a teen center. Terrence Aeriel sister, Natasha, is a junior, majoring in biology. She played the alto saxophone in the Delaware State marching band. In addition to school, lofemi Hightower held two jobs. Two of the students were juniors in college. These were the people who were destroyed by the actions of five men trying to join a gang. New Jersey has an accomplice liability law. Gerarld Gomez, 20, age 15 at the time, was convicted of murder and attempted murder. The day the students were murdered, August 4, 2007 was his birthday. He was the lookout while the students were being robbed. Shahid Baskerville pleaded guilty and was convicted and sentenced to 30 years in prison. Melvin Jovel, 22, pleaded guilty and was sentenced to life in prison. The oldest of the six defendants, Jose Carranza, 32, was convicted. He was in the country illegally and there were several warrants out for his arrest at the time of the assaults.

Irina Sergeevna Yarmolenko, 20

Ira Yarmolenko was a student attending the University of North Carolina. July 5, 2008 she was taking pictures for her student project when she was suffocated on the banks of the Catawba River. Her body was found in her car May 5, 2008. December 12, 2008 Mark Carver and his cousin, Neal Leon Cassada Jr. were arrested and charged with first-degree murder and felony conspiracy. Their bond was \$100,000 in 2009. Both men are awaiting trial. Mr. Cassada died of a heart attack in 2010 before he could be tried. The charges were dropped after his death. Mr. Carver was convicted of first-degree murder June 4, 2011. The cousins were fishing in the area.

Jacine Renee Gielinski, 22

Jacine Gielinski, a 22-year-old college student of the University of Colorado, was kidnapped, raped, and tortured April 29, 1997 by two roommates who wanted to fulfill their rapemurder fantasies. Yet we let professionals tell us men who have rape-murder fantasies are harmless. What happens to the men when the rape murder fantasy no longer satisfies them? In the book *The Career Rapist* we will answer this question. Ms. Gielinski was stabbed, her throat was slashed, her wrists were slit and she was suffocated. Her murderers are still alive. The state Supreme Court declared Colorado's three-judge death-penalty sentencing system unconstitutional and ordered life prison terms for two men on death row. The U.S. Supreme Court ruled that juries, rather than judges, must establish all of the factors necessary to sentence a convicted murderer to death Jacine Gielinski encountered her assailants at a traffic light. They followed her. They grabbed her. They sped to an elementary school parking lot where they raped her. She listened as they debated how to kill her. They slit her throat, stabbed her in the chest and smothered her. They shoved mud into her genitals in an attempt to cover up DNA evidence. They flung her body under a van.

The women of this country must wake up and begin to work together to save the lives of our sisters, mothers, and children. Women are slowly and systemically being murdered in this country, and our attention is being diverted to issues such as what dress Paris Hilton is wearing or who will Brittney Spears marry tomorrow. If you do not want your daughter, mother, niece, or

grandmother to be the next victim, then you must stand up and align yourself with other women in this country fighting violence against women. You have no idea how fluid it is to murder a woman in this country. For example: March 3, 2005 Mr. Andres Casarrubias pleaded guilty in a Palm Beach County Courthouse to three counts of first-degree murder in the death of his wife, Catalina Casarrubias, Ramiro Cortez and Andrew Logan in July 2003. Mrs. Catalina Casarrubias' six children are now motherless. Mrs. Casarrubias was shot to death at work. Before her husband shot her he said, "Are You scared?" Andrew Logan died shielding his employees from Mr. Casarrubias.

Jamie Glenda Hart, 21.

Jamie Hart was a student attending Texas A&M. Jamie Hart was murdered May 1, 1999 in Brazos County Texas. Her body was found on the roadside by a jogger. Her car was found further down the road. Ms. Hart had been strangled but beaten to death. Her body was thrown from a car. Her murder case remained unsolved until another woman was murdered in College Station, Texas. The DNA taken from the body of Carolyn Casey also matched the DNA taken from Jamie Hart's body. Both samples matched the DNA of Mr. Ynobe Katron Matthews. Mr. Matthews confessed to the murder of Jamie Hart after he was convicted of the murder of Carolyn Casey. He was sentenced to life imprisonment for the murder of Jamie Hart. He was executed January 6, 2004 for the murder of Carolyn Casey

Jana Lynne Mackey, 25,

"She believed passionately in what she was doing and was going to law school to get a degree and fight for legal rights for women, gays and lesbians and anybody she felt was oppressed. "She was always willing to step into the fight." Tom Witt, the chairman of the Kansas Equality Coalition

Jana Lynne Mackey was a Kansas University law student living in Lawrence, Kansas. She was in her second year at law school. She was also a domestic violence activist. She had worked as a rape counselor. Her body was found July 4, 2008 inside her home. Her ex-boyfriend, Adolfo Garcia-Nunez, 46, was arrested and charged with her murder. He committed suicide while in jail July 6, 2008 in Elizabeth, New Jersey. Adolfo Nunez served prison time for assaulting a former girlfriend in 2004,

Jane Mcguire, 19

Jane Maguire was a 19 year old coed living in Akron, Ohio. She moved from Washington, Pennsylvania to attend school. She was murdered September 20, 1972. Larry Joseph Via, 28, was arrested and tried for her murder. He was convicted in 1973. March 6 1973 he was sentenced to life in prison. The judge ordered that he spend every September 20th in solitary confinement meditating on the saying of Jane Mcguire. We do not see him in prison. Remember in the 1970's life was not actually life

Jane McManus, 26

Jane McManus lived in Nebraska. She was a student of photography. She was raped and murdered June 11, 1977. Murderer Status: Harold Lamont Otey, 39 was found guilty of murder and sentenced to die. He was supposed to be executed July 18, 1991 he was granted a stay of execution. Harold Lamont Otey was walking pass Jane McManus's home and saw her sleeping and decided to rob her. He broke into her home began unloading items he could carry. Rather

than leave the home when she woke he forced her upstairs where he raped her, stabbed her beat her in the head five or six times then strangled her to death. Yes this man deserves to die. He was executed September 3, 1994 after 17 years on death row. He strangled Jane McManus with his belt.

Janet Chandler,

The police kept working the murder case until they made six arrests 27 years later. Janet Chandler was a student of Hope College in Michigan. She worked at a local hotel as a night clerk to earn extra money. She was strangled to death January 31, 1979. Supposedly she was abducted but it was learned she was abducted by hotel guest raped and murdered. Murderer Status: In 2006 Laurie Ann Swank, 48, (21), Arthur Carlton Paiva, 54, (27), Robert Michael Lynch, 67, (40), Anthony Robert Eugene Williams, 55, (28), Freddie Bass Parker, 49, (22), and James Cleophas Nelson, 59, (32). Five hundred people in 18 states were interviewed to solve this case. All were convicted. Janet Chandler was murdered out of cruelty and jealousy. Her tormentors were guards working in the area during a union strike.
